# INTRODUCTION

he financial year 2003/2004 was dominated by the reflective mood associated with the celebration of "Ten Years of Democracy" in South Africa. For the KwaZulu-Natal Department of Transport, ten years of democratic government was captured in the theme "Ten Years of Prosperity – Prosperity Through Mobility."

There can be no doubt that since 1994 the KwaZulu-Natal Department of Transport has consistently and diligently fulfilled its social contract with the citizens of KwaZulu-Natal. The KwaZulu-Natal Department of Transport is strongly committed to the principles of participatory democracy and people centred development. This commitment is integral to the KwaZulu-Natal Provincial Roads Act. Our mission to be a cost efficient and cost effective service provider is premised on the fact that our public are customers who have, through their taxes, prepaid us for our services. They are entitled therefore to a Department that is easily accessible, easily understandable and user friendly. This belief is the basis on which we have restructured the KwaZulu-Natal Department of Transport to bring customer needs and customer satisfaction into sharper focus.

Essentially our challenge as the KwaZulu-Natal Department of Transport has been to:

- address the network inequalities that arose during apartheid through separate development and, at the same time, maintain the established road network at an appropriate standard
- reallocate public transport subsidies which had previously been administered not so much
  as a subsidy to transport the public but as a subsidy to reduce the costs of workers travelling
  to industrial centres
- regulate the minibus taxi industry which caters for more than 65% of the daily mobility needs of the public
- address the fact that our rate of accidents and road related fatalities is unacceptably high
- address the normalisation of the construction industry

Since 1994 the KwaZulu-Natal Department of Transport has systematically increased its budgets and increased the percentage of budgets spent on actual services to the public. So much so that the proportion of our transport budget now spent on personnel overheads is less than 22,2% of our overall budget. The downsizing of the KwaZulu-Natal Department of Transport has been accomplished within a process to right size the Department by increasing the number of professional staff in key public interest portfolios such as the Road Traffic Inspectorate, Road Safety, Economic Empowerment and Poverty Alleviation (Zibambele), Public Transport, Freight Transport and the regulation of the taxi industry. It should be noted that no staff were retrenched during the restructuring process.

A review of our performance, this financial year, provides compelling evidence that we have been able, as a Department, on an annual basis, to:

## REVERSE THE SPATIAL INEQUALITIES ASSOCIATED WITH APARTHEID AND SEPARATE DEVELOPMENT

- Our One Stop Shops are now fully operational in all regions of KwaZulu-Natal. Our budgets
  and business plans are compliant with our objective to redistribute services to achieve equity
- 450km of local road constructed under our Community Access Roads Program
- 224km of gravel road constructed under the Independent Electoral Commission (IEC) program to provide access to voting stations
- 32km of blacktop road constructed under our African Renaissance Road Upgrading Program and our Four Cities Road Upgrading Project
- 22km of other roads upgraded

- 62 causeways constructed
- 674 098 m<sup>2</sup> of blacktop road resealed

- 1 190 km of road regravelled
