

MINISTER'S OFFICE

The Office of the MEC's role is broadly defined thus:

- to support the MEC in achieving Department's goals and objectives by on one hand; transparent excellent service delivery and constant accountability to stakeholders;
- on the other hand, to build the profile and enhance the image of the MEC and the Department.

Financial year 2003/2004 marks the end of the second term of office for MEC Ndebele as the MEC for Transport KwaZulu-Natal.
