Introduction

This afternoon I have the honour to present the budget speech for the Department of Community Safety and Liaison, Budget Vote 9 under the theme '**Deepening People's Action Against Crime**'. Experience has taught us that the fight against crime and criminals requires mass mobilization and an activist approach, hence our theme. To this end, the Department is involved in educating, conscientising and mobilizing the community to cooperate with the police by being their eyes and ears in the process of building a society of non-criminals. This we do through Operation Hlasela, anchored on our strategy of Building a United Front Against Crime.

Honourable Members will know that the fight against crime and corruption is one of the priorities of our Government. We want to ensure that our vision, "The people of KwaZulu-Natal live in a safe and secure environment" is realized. We are advancing this priority and this vision by taking the Department to districts and be actively involved in the fight against crime. We need to ensure that our department becomes the **strategic centre** in the fight against crime, not to just monitor the work of the police. We must be a part of the whole societal fight against crime.

Honourable members, allow me to take a leaf on commitments made in the past financial year as this Department. We committed to host an annual MEC's Community Awards for Police Excellence, we went on record with regards to extending the Communities in Dialogue Programme to Presidential Pardons Programme, we committed to embark on a drive to reconstitute Community Policing Fora (CPFs) as well as train them to perform their functions optimally through our Thathulwazi programme. We pronounced on forming partnerships with the existing neighbourhood watches, community and street patrols that have voluntarily set themselves up as crime fighters. We committed on hosting a summit on community safety structures, work with youth formations to create a crime fighting programme targeting our youth and driven by them. We further committed to playing our part in the multi party political oversight committee on elections as well as provide election monitors in critical voting stations and critical areas.

Developments on Commitments

Chairperson, we have reached remarkable milestones in as far as the commitments made in the past budget vote. To begin with, we remain committed to awards for police excellence. In fact we have revisited our awards for police to include community crime fighting structures.

In as far as the Presidential Pardons Programme subcommittee of the Justice Crime Prevention and Security Cluster (JCPS) is concerned, we can report that the subcommittee is hands on, on this programme. It has presented both to the Committee of Heads of Departments and to the Executive Council. The principal membership of this subcommittee includes the State Security Department, the Department of Correctional Services as well as the Department of Community Safety and Liaison.

With regards to the programme to reconstitute CPFs, this is well underway and is extensively dealt with under Community Policing. In as far as the summit on community safety structures is concerned, we were able to host the summit in August 2011, wherein we emerged with resolutions which have already taken off as you will see under community policing.

As committed in the past budget speech, the Department played its part during the 2011 Local Government elections.

Honourable members, Heads of Departments for the Eastern Cape, Free State and KwaZulu-Natal were invited by the National Secretariat to discuss, and share best practices to resolve stock-theft cases along the South African Borders. This meeting came up with a resolution that the affected Provinces should prepare for the staging of the National Cross-Border Summit. The Provinces were also requested to stage Provincial Cross-Border Summits in preparation for the National Summit. The Summit concept was presented and endorsed by the KwaZulu-Natal Cabinet, on presentation by the Head of Department, Department of Community Safety & Liaison, KwaZulu-Natal. I am pleased to announce that a Provincial Cross Border Crime Prevention Summit will be held on 24 and 25 July 2012.

Programme 1: Administration

Chairperson, we are pleased to report that under programme 1 Administration, the department received an unqualified audit over the past 4 years. Our Human Resources component managed to get a bronze award during the HR Convention. This was the third consecutive year for the department featuring prominently in these awards.

Positioning Our Organisational Structure For Effective Crime Fighting

Honourable Members, an area of focus under programme 1 this financial year is organizational reviewal. Over the past year, there have been fundamental developments affecting both the mandate and strategic direction of the Department. The Department derives its mandate from sections 206 and 208 of Chapter 11 of the Constitution. Section 206(3) states that each province is entitled to –

- a. monitor police conduct;
- b. oversee the effectiveness and efficiency of the police service;
- c. promote good relations between the police and the community;
- d. assess the effectiveness of visible policing; and
- e. liaise with the Cabinet member responsible for policing in the province.

Section 208 states that, ‘a civilian secretariat for the police service must be established by national legislation to function under the direction of the Cabinet member responsible for policing’. To give effect to this provision of the Constitution, the Civilian Secretariat for Police Service Act, 2011 (Act No. 2 of 2011), was enacted. The Act requires the MEC to establish a provincial secretariat for police within 18 months of the commencement of the Act. With this in mind, the Department has already started preparations for implementation.

This development coincided with the commencement of the process to review the way the Department operates in order to more adequately implement its flagship programme of ‘Building a United Front against Crime’ through Operation Hlasela. As we review our organogram, we are taking this development on board. We have decentralised our operations to District level to get closer to the communities we serve. Our core mandates have been intensively interrogated and we have emerged with a basket of services that we are delivering with renewed vigour.

Civillian Oversight: Programme 2

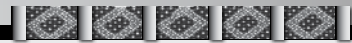
Honourable Members are aware that one of the core functions of this Department is to play an oversight role over the Police. Towards this end, the department evaluated a number of police stations, verified CPFs, Victim Support Centres and assessed specialized SAPS units. A number of interventions were also conducted to ensure greater effectiveness and efficiency of the SAPS. We even embarked on unannounced police station visits.

During station evaluations, the Department identified that infrastructure constraints are persistent and hamper the provision of optimal service delivery. The problem of long distances being travelled by some of our communities in an attempt to access police services continues to be a recurring challenge. To this end, we will continue to make recommendations for the rationalisation of police stations so that all communities enjoy equitable access to justice.

We are heartened by the pronouncements made by the Minister of Police, Mr Nathi Mthethwa in his budget vote presented to Parliament on 8 May 2012 in this regard. The Minister identified as a third priority in this financial year, the acceleration of the pace of building new police stations and correctly capacitating them with committed personnel and systems. The priority is mainly about building police stations around rural areas and townships. We look forward to the positive spin offs on this matter, particularly, its implementation in our Province.

We are also pleased to report honourable members that, as a result of our evaluations, some relief in terms of infrastructure has been arranged for stations such as Ekuvukeni whereby sixteen computers were procured. The Elandslaagte police station also received some much needed renovations as well as an allocation of two new vehicles to the station. There are other numerous good direct results following our assessments and evaluations including motivating for the establishment of a satellite station in Ndwedwe. At other stations serious challenges were uncovered which hamper effective service delivery. Findings from those were relayed to the SAPS who are attending to them.

As per the National instruction to assess the management of firearms within selected police stations in KwaZulu-Natal, our service monitors were involved in conducting assessments in various policing areas.



Honourable Members, this government has strengthened oversight over the police in ways unprecedented. The Independent Police Investigative Directorate Act (IPID ACT, No 1 of 2011) is now in place since 1 April 2012. This piece of legislation takes this investigative directorate out of the South African Police Service, thus entrenching its independence from the police. In essence the collaboration of this unit with the Department of Community Safety and Liaison is destined to yield positive results.

Through participation in Ward Committees, we intend that our community crime fighting structures participate in Operation Sukuma Sakhe programs.

Enhancing Service Delivery by the Police

Chairperson, policing is a huge responsibility. Over and above their normal duties, police are often called to intervene between communities and their public representatives over service delivery matters. In some instances, they end up at the centre of the dispute. Often times, their good work go unrecognized. We are pleased that the Minister's priorities in this financial year include a focus on smart policing, strengthening crime intelligence capacity so as to enhance the criminal justice system, as well as policing public service delivery better to reflect the, 'ethos of human rights'. Certainly, these new developments will enhance service delivery whilst assisting immensely in upholding the image of the police, including renewing and building confidence of the citizenry on the police.

This Department will continue to recognise excellence in our law enforcement officers and Voluntary Community Crime Fighting Associations. This year we will take this a step further by also awarding community crime prevention structures such as CPFs that have done an exceptional service to their communities by volunteering their time and efforts thus contributing towards a safer province. We will solicit a credible outside organization to assist us with the process and programme of evaluating performance of the Police, CPFs, Volunteers and Voluntary Community Crime Fighting Associations, for excellence. The motivation to our police service provided by these awards cannot be quantified.

We take cognizance of the fact that the Minister of Police has dubbed this year's Budget Vote as the year of the Detective; with a focus on 10 point priority deliverables. Our recognition awards will certainly take this on board as well.



Crime Prevention and Community Police Relations: Programme 3

Chairperson, our approach in the fight against crime and criminals is a proactive one. It is anchored on our strategy of Building a United Front Against Crime and driven through Operation Hlasela. The focus is on mobilising communities to fight against crime and criminals. Programmes which form part of crime prevention and community police relations include community policing, communities in dialogue programme, victim empowerment, volunteer social crime prevention programme, campaigns against police killings, youth against crime, collaboration with various stakeholders in the fight against crime as well as the Justice Crime Prevention and Security Cluster.

We are pleased to report to this House that the team from the Department recently visited Cuba to learn best practices on community based structures. This country boasts of over 50 years experience in neighbourhood watches according to the Wikipedia articles and Amnesty International websites. We have integrated these best practices in our programmes. We have furthermore conducted workshops to our community based structures in a drive to ensure that we strengthen their capacity to fight against crime and criminals. We are hopeful of positive outcomes arising out of our crime fighting programmes.

Community Policing

Honourable Members, we move from the premise that community participation must be structured. This philosophy stretches to the formation of the Community Policing Fora (CPFs). The department must make it its task to assist communities to form and sustain Community Policing Fora. These must also be formed in terms of the law and in line with their own Constitutions. We will also co-ordinate, reconstitute, strengthen, capacitate and assist Voluntary Community Crime Fighting Associations.

Honourable members, part of our effort towards ensuring the effective functioning of the CPFs has culminated in an agreement between the MEC and the Provincial Commissioner of the SAPS to appoint an interim steering committee to lead the CPFs towards establishing a new proper constitution.

Once that process is finalised, we envisage that a new provincial CPF board will then be elected. Members may all be aware that part of the problems impacting on the functioning of these structures is that elections had not been held in a very long time. With the new constitution in place this is now going to be possible.

Voluntary Crime Fighting Associations

The establishment of vigilante groups which are operating in Umzinyathi, Ulundi, Amajuba and other Districts has been of great concern to the Department. Community members suspected of being involved in stock theft are victimised by these structures. In my discussions with informal structures on 15 August 2011, I stressed that all crime combating must take place strictly within the boundaries of the law. Through the new umbrella organisation called KwaZulu-Natal Community Crime Prevention Association KZNCCPA, the Department will provide capacity to these structures to enable them to make a positive contribution to preventing crime.

Peace Building In Communities

Chairperson, the Department of Community Safety and Liaison working together with the police, also plays a leading role in the promotion of peace, democracy and social cohesion through the Communities in Dialogue Programme. These were held in a number of areas such as Mtshezi, Mafakatini, Hlabisa, Greytown, Besters, Mpungamhlophe, Loskop, Sydenham, Verulam Waterloo, Tongaat, Loskop, Hlabisa, Pongola, Elandslaagte, Mbongolwane, Colenso, eMankengani and Greytown. The Department has also been involved in peace building interventions at tertiary institutions.

In response to Political Conflicts which have troubled our Province, the Department led the Provincial Multi-Party Political Oversight Committee on Elections to ensure peace and stability in preparation for the May 2011 Local Government Elections. The committee visited those areas which were regarded as politically sensitive. The committee visited Mbabazane/ Mtshezi precinct; Greytown/ Msinga precinct; Ulundi/ Nongoma precinct; KwaDukuza/ Mandeni/ Maphumulo precinct; and Ethekwini Hostels. The Provincial Multi-Party Political Prayer was successfully staged in Matimatolo, Greytown on 9 May 2011. A



prayer rally was hosted in Nongoma on 30 September 2011, post the elections. We remain hopeful that KwaZulu-Natal will cease to be a volatile Province through such interventions. We will therefore continue the Multiparty Political interventions and permanently inculcate the culture of political tolerance and peaceful co-existence.

Police Killings

Honourable Members, we commit ourselves to take forward the resolutions of the summit against police killings through clearly defined programmes. We value our protectors and their contribution in the fight against crime. We want communities to play a central role in the implementation of these resolutions.

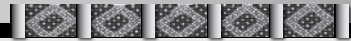
We are happy to announce that we have had structures coming forward to state their roles towards eradicating this scourge. We commend Police and Prisons Civil Rights Union

(POPCRU) for heeding our call and coming forward to state their role towards taking the resolutions of the summit forward. We have also had community crime prevention associations coming forward through their newly drawn constitution, stating their role in this war against crime and police killings.

Victim Empowerment

Chairperson, crimes against women and Children are a priority for this government. It is becoming too common to hear of these crimes throughout our communities. Much as these crimes are difficult to police as they happen largely within trusted family circles, as government we cannot fold our arms. To this end, we welcome the Minister of Police's assertion in his budget vote that, the Family Violence, Child Protection and Sexual Offences Units (FCS) has been reintroduced in all SAPS clusters in the country. This Department, working together with the police has a huge task of strengthening this unit so that we are able to serve our constituencies better.

The Department has a role to drive social crime prevention programmes throughout our communities. In partnership with the National Prosecuting Authority, the Department conducted capacity building workshops for SAPS and the community, on Gender Based Violence, the Sexual Offences Act and the



Domestic Violence Act. Through our teams at District level, we will continue addressing challenges in implementation of these legislations and support programmes at local level aimed at rights education and promotion of human rights in general.

The Department furthermore creates awareness of protective rights for children in partnership with various stakeholders through road shows on Kuyoze Kube Nini which is a comic book and DVD that educate about domestic violence.

The subject of Human Trafficking continues to raise eyebrows and as such, the department intensified its education campaigns against the scourge. Lately, the links of Human Trafficking to drug trafficking are beginning to surface. Working together with other departments in the social cluster and the JCPS cluster, the department will continue with its efforts to create awareness about the impact of substance abuse to individuals and society as a whole.

Youth Against Crime

Chairperson, we hold the view that the youth are critical in the fight against crime and criminals. Any crime fighting programmes which exclude the youth are generally flawed. In partnership with the SAPS Provincial Office, the Department embarked on a process of verifying the existence of CPF Youth Desks throughout the province for the purpose of capacitating these structures. Youth Desk structures at Mpumalanga, Osizweni, Eshowe, Jozini and Cato Manor have been capacitated. We look forward to taking this programme to all districts for maximum crime fighting output.

We are working on a comprehensive program to revive the Youth Desk right across the Province. We also want to assist them to re-launch their structures at all levels.

Volunteer Social Crime Prevention Project

Madam Speaker, the Volunteer Social Crime Prevention Project involves the recruitment and deployment of volunteers to embark on social crime prevention activities at community level. From 1 April to 17 October 2011, volunteers were deployed in all 11 districts thereby achieving the target that was set to ensure that all 11 district municipalities are sufficiently resourced with trained



volunteers to deal with Social Crime Prevention. Linking the volunteers with our District teams will ensure better management and oversight over the work that they do at a local level. This will also ensure that the programmes they embark on really address the needs of their local communities, as opposed to those developed at a provincial level. The Department of Community Safety and Liaison is currently working on a programme to build the early warning capacity within the Volunteer Social Crime Prevention Project. We also want to work on making the volunteers to work together with other community crime fighting structures.

Collaboration with Stakeholders

Honourable Members, the fight against crime and criminals requires collaboration with various stakeholders. The department will identify all other role players and their roles in 'Building A United Front Against Crime'; and work closely with these formations. As we embark on the exercise to rebuild CPFs for instance, we must define their role in reference to ward committees in view of the inherent competition for political hegemony. To this end, we must therefore engage the Department of Co-operative Government and Traditional Affairs (COGTA) to together define the roles of CPFs and ward committees in the fight against crime. Equally, the department and COGTA must negotiate the role of municipalities in fighting crime and ensure that crime prevention is not just a temporary project, but a permanent programme of all the spheres and Departments of our Government.

Traditional leaders are encouraged to be actively involved in community safety structures within their areas. The department has held capacity-building workshops for *Amakhosi* and members of Traditional Councils in partnership with the Department of Co-operative Governance and Traditional Affairs.

We must equally also partner with the Department of Social Development and many other relevant partners in the fight against substance abuse including other social ills. As part of the Substance Abuse Awareness Programme, a meeting involving Licensed Liquor Traders was held. The Department has partnered with the SAPS, the Department of Transport as well as the Department of Economic Development and Tourism's Liquor Board to initiate a series of Liquor Forum meetings promoting responsible trading and consumption of alcohol in various areas. These have commenced at Dundee and eNquthu.



The training manual '*Making Our Schools Safe*' continues to form the central pillar for the school safety capacity building offered by the Department working in partnership with the Department of Education. This year, we are concretely pursuing collaboration with the Department of Sports and Recreation with regards to sport against crime programs.

Justice Crime Prevention And Security Cluster (JCPS)

Honourable Members, the Justice, Crime Prevention and Security Cluster (JCPS), which is made up of the Criminal Justice Departments and our social sector partners, is a very effective governance mechanism for delivering integrated services to our people whilst providing an open platform for dialogue with departments from various levels of government in an effort to close the blockages in the Criminal Justice System and civil society. JCPS Cluster in KwaZulu-Natal has reached an unprecedented level of cooperation. Also notable among the successes in this area of our operations is the mediation of conflicts within the taxi industry through integrated responses from the JCPS Cluster.

The JCPS cluster is comprehensively addressing the stock theft matter which remains a cause for concern to us as government and the affected people. The areas identified as stock theft hotspots in the Province are Ladysmith, Utrecht, Bulwer, Bergville, Ezakheni, Hlobane, Dannhauser, Amangwe, Paulpietersburg, Vryheid, Ekuvukeni, Estcourt, Nongoma, Elandslaagte, Kwa-Mbonambi, Impendle, Kwa-Msane, Taylor's Halt, Himeville, Intsikeni, Maphumulo, Gluckstadt, Besters, Plessisslaer and Dumbé. The Department is visiting the affected areas to address stock theft issues. The Department, in liaison with the Department of Agriculture, Environmental Affairs and Rural Development, facilitated the branding of live stock province wide. A stock theft prevention plan was developed in partnership with the JCPS Cluster Departments. The curbing of stock theft will contribute to the development of our rural communities.

The Justice Crime Prevention and Security Cluster will continually strategize on legal imperatives. This will entail evaluating whether we need new policies or we need to review old ones. Furthermore, whether there are implementation weaknesses that need to be remedied. It must facilitate informed interventions through setting up relevant task teams/sub-committees so as to impact positively in the fight against crime and criminals.





The subcommittee on Presidential pardons is a brain child of this cluster. It is executing its task as mandated by the cluster. This is a crucial step in the integration of our society. More work remains to be done in this sub committee to drive the integration of former inmates to the wider society.

Conclusion

Chairperson, it is worth mentioning that continuous research, monitoring and evaluation of our Crime Fighting Strategy is a key success factor to our crime fighting programmes. We will execute this mandate diligently so that we keep and remain abreast of our crime fighting strategies and programmes.

Honourable Members, this is a department with a small budget, especially when you compare its mandate of fighting crime as one of the five key priorities of our government as well as the demand for service delivery. The department therefore needs to explore how to increase it in line with our programmes, or alternatively tap into other sources of funding to fight against crime, especially business, but not only through Business Against Crime.

Chairperson, we will communicate our crime fighting programmes and strategies so as to enhance and augment our mass mobilization strategies and initiatives. We want every district, every ward, every household and every individual to know and partner with us on our crime fighting programmes.

As I conclude, allow me on behalf of my department to express our appreciation to the police in KwaZulu-Natal under the stewardship of Lieutenant General Ngobeni, for having contributed immensely towards the decrease in some codes of crime, as seen on the latest crime statistics. The quality of work they performed before, during and after the Local Government Elections, is also commendable as they managed to quell tensions in some parts of the province that had the potential of ruining the experience of voting for a lot of ordinary citizens. Major visible policing operations were successfully executed during the Easter weekend, festive season and COP 17 climate change summit amongst others.

I wish to extend my sincerest thanks to the Interim CPF Steering Committee led by Mr. Sibaca, the different voluntary community crime fighting structures

for their work in the fight against crime and for agreeing to work with the Department within the legal framework and in the spirit of co-operation. The role of community policing as played by the crime fighting structures and all our partners in the United Front Against Crime cannot be over emphasized.

I also thank the Department of Community Safety and Liaison led by Mr. R V Bhengu for their support and contribution in championing service delivery. The milestones achieved in our crime fighting strategies and initiatives owe their success to your continued efforts.

My sincerest gratitude goes to my wife and family for their undying support. To the government of KwaZulu-Natal, under the stewardship of the Premier we salute your contribution to the marked improvement of the quality of lives of our people.

To the organisation that bestowed its confidence in me to lead this portfolio, the African National Congress, I salute you!!!

I look forward to visible and positive spinoffs as we deepen our activism in the fight against crime and criminals.

AmaLungu aHloniphekile azoqonda ukuthi impi yokulwa nobugebengu nenkohlakalo yikona esiyiqhakambisayo kulo Hulumeni wethu. Sifuna ukuqinisekisa ukuthi umbono wethu othi, "Izakhamizi zaKwaZulu-Natali zihlale endaweni ephephile nevillelekile" uyafezeka. Lombono siwusa phambili ngokuletha umNyango ezifundeni ukuze nazo zibambe iqhaza kulempi yobugebengu. Sidinga ukuqinisekisa ukuthi umNyango wethu uhlala uba yisizinda sokwakha amasu okulwa nobugebengu, hhayi nje ukuqapha ukusebenza kwamaphoyisa kuphela. Kumele sibe yingxenye yokulwa nobugebengu emiphakathini yethu.

Malungu aHloniphekile, ngivumeleni ukuba ngidlule kwezinye zezinto ebesizibophezele kuzona njengomNyango onyakeni wezimali odlule. Sazibophezela ngokuklomelisa amaphoyisa asebenza kahle; sabuye sathembisa ukwenabisa uhlelo lwezithangami zokuxoxisana kwemiphakathi, esithi i-Community in Dialogue, ukuba lufinyelele ohlelweni lukashwele kaMongameli, i-Presidential Pardons Programme; sazibophezela ngokuvuselela kabusha ama-Community Policing Forum (CPF) kanye nokuwaqeqesha ukuze enze umsebenzi wawo ube sezingeni elifanele ngaphansi kohlelo lwethu iThathulwazi.

Siye samemezela ukwakha ubambiswano nezinhlaka ezingamavolontiya okuqapha ubugebengu emiphakathini. Sazibophezela ngokwenza ingqungquthela yezinhlaka zokuphepha emiphakathini, ukusebenza nezinhlaka zentsha ukuze kube nohlelo lokulwa nobugebengu olubhekene nentsha ngqo lubuye lushayelwe yi-yona futhi. Saqhubeka sazibophezela ekubambeni iqhaza emsebenzini wethimba elihlanganise



amaqembu epolitiki ehlukene, sibuye siqhubeke nokuqapha ngesikhathi sokhetho kulezo zikhungo nezindawo ezazibonakala zingenalo uzinzo.

Okwenzekile Ngezibophezelo

Sihlalo, sesihambe ibanga elide kulokhu esasizibophezele kukona ngesabelo mali esedlule. Sisalokhu sizibophezele ngokuklomelisa lawo maphoyisa enze kahle. Empeleni silubuyekile lolu hlelo lwethu lwemiklomelo ukuze sifake nezinhlaka zomphakathi ezilwa nobugebengu futhi manje.

Ngokohlelo lwekomidi elibhekele ushwele kaMongameli ngaphansi kwe-Justice Crime Prevention and Security Cluster (JCPS), sesingakusho ukuthi ikomidi liphezu kwawo lowo msebenzi. Selizenzile izethulo nasekomidini leziNhloko zemiNyango kanye nasesiGungwini seKhabhinethi. Amalungu aleli komidi ahlanganisa umNyango wezokuPhepha kwezwe, umNyango wezokuHlumelelisa iziMilo kanye nomNyango wezokuPhepha nokuXhumanisa uMphakathi.

Ohlelweni lokwakha kabusha ama-CPF, umsebenzi uyaqhubeka kanti usingathwe ngeqophelo eliphezulu – loku kuzophinde kuvele kulo mbiko ngaphansi kwesihloko esibhekene ne-Community Policing. Mayelana nengqungquthela yezinhlaka zokuphepha komphakathi, sikwazile ukuthi sibe nale ngqungquthela ngo-August wangonyaka odlule, nokuyilapho siqhamuke nezinqumo eseqalile ukusebenza njengoba nizozibona ngaphansi kwezinhlelo zokusebenzisana kwamaphoyisa nomphakathi.

Njengoba sasizibophezele enkulumweni yesabelo-mali esedlule, umNyango wabamba iqhaza elibonakalayo ngesikhathi sokhetho loHulumeni baseKhaya lwango-May 2011.

Uhlelo 1: Ezokuphatha

Sihlalo, kuyasithokozisa ukubika ukuthi ngaphansi kohlelo lwezokuphatha, umNyango utholwe ungenachashaza ngumcwaningi wamabhuku ezimali kule minyaka emine edlule. Uphiko lukandabazabantu, i-Human Resource, lukwazile ukuthola indondo ye-bronze ngesikhathi kunomcimbi wemiklomelo yalolu phiko kwi Human Resource Convention. Bese kuyiminyaka emithathu ilandelana umNyango ubambe iqhaza elibonakalayo kule miklomelo.



Ukuhlelwa Kwesakhiwo Somnyango Ukuze Kuliwe Ngempumelelo Nobugebengu

Malungu aHloniphekile, indawo edinga ukubhekwa kabanzi ngaphansi kohlelo lokuqala ngalo nyaka wezimali ukubuyekizwa kwezikhundla zabasebenzi. Kusukela ngonyaka odlule, sekube khona inqubekela-phambili ethinta umgomo umNyango obekelwe wona ngokomthetho kanye namasu okuya phambili njengomNyango. UmNyango usebenza ngokulawulwa isigaba 206 no-208 wesahluko 11 soMthethosisekelo. Isigaba 206(3) sikubeka kucace ukuthi leso naleso sifundazwe sinegunya lokuthi-

- siqaphe ukuziphatha kwamaphoyisa;
- sibhekelele ukusebenza kwamaphoyisa ngempumelelo nangesikhathi esifanele;
- sikhuthaze ukusebenzisana phakathi kwamaphoyisa nomphakathi;
- sibheke ukuthi amaphoyisa ahlale ebonakala;
- sixhumane nelungu leKhabhinethi elibhekene nokusebenza kwamaphoyisa esifundazweni.

Isigaba 208 sibalula ukuthi kumele kube nengxenye yokusebenza kwamaphoyisa emele izakhamizi okuthiwa yi civilian secretariat esungulwa umthetho kazwelonke isebenze ngaphansi kolawulo lwelungu leKhabhinethi elibhekene nezindaba zokusebenza kwamaphoyisa. Ukwenza sisebenze lesi sigaba soMthethosisekelo, kudingeke kube nomthetho i-Civilian Secretariat for Police Service Act, ka-2011 (u-Act No.2 ka-2011). Lo mthetho udinga ukuthi uNgqongqoshe wesifundazwe asungule le ngxenye engeyona eyamaphoyisa ezinyangeni ezingu-18 kusukela uqalile lo mthetho. Ngokuba nalokhu emqondweni, umNyango usuqalile ukulungiselela ukwenza lokhu.

Lokhu kwenzeka ngesikhathi esisodwa nokuqala kohlelo lokubuyekiza indlela umNyango osebenza ngayo ukuqinisekisa ukuthi luya phambili uhlelo lokwakhiwa kombimbi lokulwa nobugebengu kusetshenziswa u-Operation Hlasela. Njengoba sihlela kabusha uhla lwemisebenzi ngokohlaka lomNyango, nalokhu ngeke sikushiye ngaphandle. Umsebenzi sesiwehlisele nasemazingeni ezifunda ukuze sisondele emiphakathini esiyisebenzelayo. Imigomo esisebenza ngaphansi kwayo sesiyicubungulise kakhulu sase siqhamuka nomthamo wezinsiza okumele sizilethe ngomfutho kubantu.



Ukusebenza Kwezinhloka Ezimele Imiphakathi (Civilian Oversight): Uhlelo 2

Amalungu aHloniphekile ayakuqonda ukuthi eminye yemisebenzi yalo mNyango ngokubhekelela ukusebenza kwamaphoyisa. Ukuze kwenzeke loku, umNyango uke wabheka iziteshi zamaphoyisa eziningi, waqinisekisa ubukhona kwama-CPF, izikhungo ezisiza izisulu esithi ama-Victim Support Centres, wabuye wabhekisa ukusebenza kwamathimba akhethekile e-SAPS. Sekube nokungenelela okuningi ukuqinisekisa ukusebenza ngendlela kwamaphoyisa e-SAPS. Sibuye saba nohlelo lokuvakashela iziteshi zamaphoyisa kungazelele muntu.

Ngesikhathi sokuhlola iziteshi, umNyango wathola ukuthi kunokushoda kwengqala-sizinda nokwenza kube nomthelela ongemuhle ekwenziweni komsebenzi. Inkinga ebhekene nezakhamizi yokuhamba amabanga amade ukufinyelela eziteshini zamaphoyisa isalokhu iqhubekile. Sizokhubeka nokwenza imizamo yokulungisa izimo zeziteshi zamaphoyisa nokuzokwenza ukuthi imiphakathi ikwazi ukufinyelela endaweni yomthetho.

Sisithokozise kakhulu isimemezelo esenziwe nguNgqongqoshe wamaPhoyisa uMnuz Nathi Mthethwa ngalolu daba ngenkathi ethula isabelo-mali sakhe ePhalamende mhla 8 May 2012. UNgqongqoshe wakubeka kwaba yinto yesithathu eseqhulwini ohlwini lwakhe kulo nyaka wezimali ukunyusa isivinini ekwakhiweni kweziteshi zamaphoyisa nokuthi zibe nezinsiza-kusebenza ezisezingeni elifanelekile kanye nabasebenzi abazimisele ngomsebenzi wabo. Okuyikhona okuseqhulwini ukwakhiwa kweziteshi zamaphoyisa ezindaweni zasemakhaya nasemalokishini kulesi sifundazwe sethu.

Kuyasijabulisa futhi ukubika maLungu aHloniphekile ukuthi ngemuva kocwaningo lwethu sekukhona asebezohlomula ngokwengqalasizinda njengasesiteshini sasekuVukeni esesizothola amakhompyutha angu-16. Isiteshi sase-Elandslaagte naso sithole ukulungiswa sabuye sathola nezimoto ezintsha zamaphoyisa ezimbili. Ikhona eminye imiphumela emihle elandela ucwaningo okuhlanganisa ukuvela kwezizathu zokuba kwakhiwe isiteshi esiyigatsha eNdwedwe. Kwezinye iziteshi kwatholakala izinselelo ezinkulu ezinomthelela ekuphazamisekeni komsebenzi. Okwatholakala ngalezi zinselelo kwedluliselwa kwi-SAPS okuyiyona ebhekene nazo njengoba ngikhuluma nje.





Ngokomyalelo ophuma kuzwelonke wokuba kubhekwe ukuphathwa kwezibhamu eziteshini zamaphoyisa ezithile zaKwaZulu-Natal, ithimba lethu libe yingxenywe yokwenza lo msebenzi ezindaweni ezahlukenene.

Malungu aHloniphekile, lo Hulumeni useqinise indlela yokuqapha ukusebenza kwamaphoyisa ngendlela engakaze ibonwe. Umthetho we-Independent Police Investigative Directorate Act (IPID Act No 1 of 2011) usuyasebenza kusukela ngomhlaka 1 April 2012. Lo mthetho uyalukhipha lolu phiko ngaphansi kwe-SAPS ukuze kuqinisekiswa ukuzimela kwalo ngaphandle kwamaphoyisa. Okusempeleni ukuhlenganiswa komsebenzi walolu phiko nowomNyango wezokuPhepha nokuXhumanisa uMphakathi kubukeka kuzoba nemiphumela emihle.

Ukuphuculwa Kokulethwa Kosizo Ngamaphoyisa

Sihlalo, ubuphoyisa ngumsebenzi onzima kakhulu. Ngaphezu kwemisebenzi yawo ejwayelekile, amaphoyisa abuye abizelwe ukuzongenelela phakathi kwemiphakathi nabamele imiphakathi mayelana nezindaba ezithinta ukulethwa kwentuthuko. Kwezinye izikhathi abuye azithole esengene khaxa engxabanweni. Kwezinye izikhathi, imisebenzi yawo emihle igcina ingasabonakali. Kuyasithokozisa ukuthi izinto eziseqhulwini zikaNgqongqoshe ngalo nyaka wezimali zihlanganisa ubuphoyisa obuhle, ukuqinisa izinga lobuchwepheshe bokulwa nobugebengu ukuze kuzophuculwa uhlelo lwezobulungiswa kanye nokuphucula ezokulethwa kwezidingo kuqhakanjiswa amalungelo abantu. Akungabazeki ukuthi lokhu kuzophucula ukulethwa kwezidingo zomphakathi kube futhi kusiza ekugcineni isithunzi samaphoyisa futhi kube nokuzethemba emaphoyiseni.

UmNyango uzoqhubeka nokuhakambisa ukusebenza ngokusezingeni elifanelekile kwamalunga amaphoyisa namavolontiya ngaphansi kwe-Voluntary Community Crime Fighting Associations. Kulo nyaka sizoklomelisa nezinhlaka ezisebenzisana namaphoyisa ukulwa nobugebengu ezifana nama-CPF, ikakhulukazi ezisebenze kahle nomphakathi ngokunikela ngesikhathi sawo emizamweni yokugcina lesi sifundazwe singesiphephile. Sizobe sesinxusa nezinhlangano ezaziwayo ezizimele ukuba zizosilekelela ukuhlola ukusebenza kwamaphoyisa, amalunga e-CPF, amavolontiya kanye nososeshini bezinhlaka zemiphakathi ezisebenza ngokuzinikela ukulwa nobugebengu. Imiklomo yalolu hlobo iletha ukukhuthazeka okukhulu emaphoyiseni akithi nemiphakathi ebambisene nawo.



Siyakuqaphela futhi ukuthi uNgqongqoshe wamaPhoyisa ubeke lo nyaka wezimali njengonyaka wabaseshi, kugxilwe kakhulu emaphuzwini ayishumi. Ngenkathi senza imiklomelo sizokusebenzisa nalokhu.

Ukunqanda Ubugebengu Nobudlelwano Phakathi Kwemiphakathi Namaphoyisa: Uhlelo 3

Sihlalo, indlela yethu yokulwa nobugebengu ngeqinisekisa ukuthi sibuvimba bungakenzeki ubugebengu. Le ndlela isekeleke ohlelweni lwethu lokwakha umbimbi lokulwa nobugebengu ngokusebenzisa u-Operation Hlasela. Inhlaliso ngqangi yethu ukuvukuza imiphakathi ukuthi ibambisane nabomthetho ekulweni nobugebengu nezigilamkhuba. Izinhlelo ezilekelela ukunqanda ubugebengu nokugcina ubudlelwano obuhle phakathi kwamaphoyisa nemiphakathi kuhlenganisa ukuthi imiphakathi isebenzisane namaphoyisa, uhlelo lokuxoxisana kwemiphakathi, ukulekelelwa kwezisulu zobugebengu, uhlelo lwamavolontiya, imikhankaso elwa nokubulawa kwamaphoyisa, intsha elwa nobugebengu, ukuhlanganyela kwezinhlelo ezihlukene empini yokunqanda ubugebengu kanye nohlelo lwe-Justice Crime Prevention and Security Cluster.

Kuyasithokozisa ukubikela le Ndlu ukuthi ithimba loMnyango muva nje belihambe e-Cuba ukuyothekela ulwazi ngezinhlelo zomphakathi njengoba leli lizwe lihamba phambili ngalokhu. Sihlanganise lezi zindlela esizitholile ohlelweni lwethu. Sibe nezigawu ezinhlelo zemiphakathi yethu ukuqinisekisa ukuthi siqinise amaxhama empini yobugebengu nezigilamkhuba. Sinethemba lemiphumela emihle ezophuma kulezi zinhlelo zokulwa nobugebengu.

Umphakathi Ekubhekeni Ukusebenza Kwamaphoyisa

Malungu aHloniphekile, sisamile emgomweni wokuthi kumele sibe nezinhlelo zokubandakanya izinhlelo zomphakathi. Lo mqondo yiwona osiholela ekwakhiweni kwama-Community Policing Forum (CPF). UmNyango kumele wenze kube umsebenzi wawo ukwelekelela imiphakathi ukusungula nokugcina





i-Policing Forum isebenza. Lokhu kumele kwenziwe ngaphansi komthetho kanye neMithetho-sisekelo yawo. Siyaqhubeka futhi nokugqugquzela, sakhe kabusha, siqinise, sandise futhi silekelele i-Voluntary Community Crime Fighting Associations.

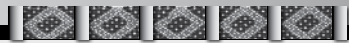
Malungu aHloniphekile, omunye umzamo wethu wokuqinisekisa ukusebenza okugculisayo kwama-CPF uholele ekutheni kube nesivumelwano phakathi kukaNgqongqoshe noKhomishana ekuqokeni ikomidi elilawulayo lesikhashana ukuhola ama-CPF ekusunguleni umthetho-sisekelo oqondile omusha. Uma lokhu sekuqediwe, silindele ukuthi kukhethwe ibhodi le-CPF elisha lesifundazwe. Amalungu azoqonda ukuthi ingxenye yezinkinga ezinomthelela ekusebenzeni kwalezi zinhla ngukuthi ukhetho aluzange lube khona esikhathini eside. Ngomthetho-sisekelo omusha sibona lokhu sekuzokwenzeka.

Amaqembu Okulwa Nobugebengu

Ukusungulwa kwamaqembu alwa nobugebengu asebenza eMzinyathi, oLundi, eMajuba nakwezinye izifunda sekube yinto ewukhathazayo umNyango. Amalungu omphakathi asoleka ngokubandakanyeka ekuntshontshweni kwemfuyo ajeziswa ngesihluku kulezi zinhla. Esinqumweni sami ngezinhla ezingekho emthethweni mhlaka-15 Agasti 2011, ngakugcizelela ukuthi konke ukulwa nobugebengu kumele kwenzeke ngendlela esemthethweni. Ngokohlaka olusha olwaziwa ngokuthi yi-KwaZulu-Natal Community Crime Prevention Association (KZNCCPA), uMnyango uzohlinzeka ngosizo kulezi zinhla ukwenza ukuthi bafake igalelo kulo mkhankaso wokulwa nobugebengu.

Ukwakhiwa Koxolo Emiphakathini

Sihlalo, umNyango wezokuPhepha nokuXhumanisa uMphakathi ngokusebenza ngokuhlanganyela namaphoyisa badlala indima ekuletheni ukuthula, intando yeningi kanye nokuhlangana kwemiphakathi ngokohlelo lokuxoxisana kwemiphakathi okwenziwa ezindaweni ezahlukeni ezifana naseMtshezi, Mafakatini, Hlabisa, Greytown, Besters, Mpungamhlophe, Loskop, Sydenham, Verulam, Waterloo, Tongaat, Pongola, Elandslaagte, Mbongolwane, Colenso, eMankanganeni naseGreytown. Ngaphandle kwalokho umNyango ubambe iqhaza ekungeneleleni ekulethweni kokuthula ezikhungweni zemfundo ephakeme.



Odabeni lokungaboni ngaso linye kwezinhlangano zepolitiki okuke kwahaqa isifundazwe, umNyango wahola ikomidi elibizwa ngokuthi yi-Provincial Multi-Party Political Oversight Committee ngesikhathi sokhetho ukuqinisekisa ukuthi kunokuthula nokuzinza ngesikhathi sokulungiselela ukhetho loHulumeni baseKhaya lwango-May wonyaka odlule. Leli komidi lahambela lezo zindawo ezabe zaziwa ngokuba nodlame lwamaqembu ezipolitiki. Lahambela izindawo zaseMbabazane/Mtshezi, Greytown/Msinga, Ulundi/Nongoma, KwaDukuza/Mandeni/Maphumulo nasemahostela aseThekwini. Kwaba nomkhuleko wesifundazwe owaba yimpumelelo enkulu eMatimatolo, eGreytown ngomhlaka 9 May 2011. Enye i-rally yomkhuleko yaba KwaNongoma ngo-30 September 2011 ngemuva kokhetho. Sisenethemba lokuthi iKwazulu-Natal izogcina iphumile ekubeni isifundazwe esinodlame uma kuqhubeka kungenelela kwalolu hlobo. Sizokhubeka nokungenelela ngaleli thimba lamaqembu epolitiki ukuze ekugcineni sigxilise isiko lokubekezelelana kwezepolitiki nokuhlalisana ngokuthula.

Ukubulawa Kwamaphoyisa

Malungu aHloniphekile, siyazibophezela ukuhlabela phambili nezinqumo ezaphuma ngesikhathi kunengqungquthela emayelana nokubulawa kwamaphoyisa. Siyabahlonipha abavikeli bethu abangamaphoyisa neqhaza abalibambayo ekulweni nobugebengu. Sifisa ukuthi imiphakathi idlale indima ekufezekiseni lezi zinqumo.

Kuyasijabulisa ukumemezela ukuthi sibe nezinhlaka ezivelayo zisho ukuthi zizobamba liphi iqhaza ekulweni nalesi sikhava. Sibonga inyunyana i-Police and Prisons Civil Rights Union (POPCRU) ngokusabela ikhwela lethu basondela basho ukuthi qhaza lini abangalibamba ukufezekisa izinqumo zengqungquthela. Kunososeshini bezinhlaka zemiphakathi ezilwa nobugebengu nabo abasondelile beza nomthetho-sisekelo wabo omusha, okuveza kucace ukuthi iyiliphi iqhaza abazolibamba ekulweni nobugebengu nokubulawa kwamaphoyisa.

Izindlela Zokuthuthukisana

Sihlalo, ubugebengu obuqondiswe kwabesifazane nezingane kuyinto ebekwe eqhulwini yilo Hulumeni. Sekuyinto ejwayelekile ukuthi kuhlale kuzwakala ngalolu hlobo lobugebengu emiphakathini yethu. Nakuba esikhathini esiningi amaphoyisa ethola kunzima ukubhekana nalolu hlobo lobugebengu ngenxa yokuthi benzeka emindenini ekufihlayo lokho, njengoHulumeni angeke sihlale





sisonge izandla. Yingakho-ke, sekusungulwe kabusha ithimba le-Family Violence, Child Protection and Sexual Offences Unit (FCS) kuwona wonke ama-cluster akwa-SAPS ezweni.

UmNyango ngokusebenzisana namaphoyisa unomsebenzi omkhulu wokuqinisa leli thimba yikhona sizokwazi ukulekelela kangcono abantu abadinga usizo lwalolu hlobo.

UmNyango uneqhaza olibambile lokugqugquzela izinhlelo zokunqanda ubugebengu kuyo yonke imiphakathi yakithi. Ngokubambisana nabe-National Prosecuting Authority, umNyango wenze umhlango wokucobelelana ngolwazi obandakanya amaphoyisa nomphakathi, kubhekwa izinto ezithinta udlame lobulili, umthetho wamacala okuhlukumeza ngocansi nomthetho wodlame lwasekhaya. Ngokusebenzisa amathimba ethu ezingeni lezifunda sizoqhubeka nokubhekana ngqo nezingqinamba ezisekhona ekusebenzeni kwale mithetho nezinhlelo zokwesekelana ezingeni lendawo okuhloswe ngakho ukufundisa ngamalungelo nokukhuthaza amalungelo esintu jikelele.

UmNyango wenza imkhankaso yokuvikelwa kwamalungelo ezingane ngokuhlanganyela nezinhlelo esisebenzisana nazo ngaphansi kwe-Kuyoze Kube Nini, okuwuhlelo olwenziwa ngencwadi enamahlaya kanye ne-DVD efundisa ngodlame lwasekhaya.

Udaba lokushushumbiswa kwabantu lusaqhubeka nokuqwebula amehlo kwabaningi, ngalokho umNyango uqinisa imikhankaso yokufundisa ngalesi sikhala. Muva nje, sekubonakala kunokuxhumana phakathi komkhuba wokushushumbiswa kwabantu nokushushumbiswa kwezidakamizwa. Ngokusebenzisana neminye imiNyango, umNyango uzoqhubeka nemizamo yokwenza imikhankaso yokuqwashisa ngomthelela wokusetshenziswa kwezidakamizwa kumuntu ngamunye nasemiphakathi-yonkana.

Intsha Elwisana Nobugebengu

Mama Somlomo, sinombono wokuthi intsha yiyo ebaluleke kakhulu empini yokulwa nobugebengu. Sikhulwa ngokuthi noma yiziphi izinhlelo zokulwisana nobugebengu ezibeka eceleni intsha angeke ziphumelele. Ngokusebenzisana namaphoyisa e-SAPS ehhovisi lesifundazwe, umNyango usezinhlelweni zokubhekisisa ukusebenza kwe-Youth Desk esifundazweni sonke ngenhloso



yokulungisa lezi zinhla. Izinhla ze-Youth Desk eMpumalanga, Osizweni, Eshowe, Jozini nase-Cato Manor zona sezilungisiwe. Silindele ukubona lolu hlelo lusabalala kuzona zonke izifunda ukuze siqinise amagalelo empini yobugebengu. Kukhona uhlelo esilusebenzayo lokuvuselela isakhiwo se-Youth Desk esifundazweni sonke. Sifuna nokubalekelela ukuba bethule kabusha izinhla zabo kuwo wonke amazinga.

Uhlelo Lwamavolontiya Lokunqanda Ubugebengu

Mama Somlomo, uhlelo lwamavolontiya okulwa nobugebengu luhlanganisa ukuqashwa kanye nokutshalwa kwamavolontiya ekunqandeni ubugebengu ezingeni lemiphakathi. Kusukela ngomhla 1 April ukuya ku-17 October 2011, amavolontiya atshalwa kuzona zonke izifunda ezingu-11 ukufika esibalweni esabekwa sokuqinisekisa ukuthi bonke oMasipala bezifunda bahlonyisiwe baphelele ngamavolontiya ukubhekana ngqo nokulwa nobugebengu. Ukuhlanganisa amavolontiya namathimba ethu esifunda kuzoqinisekisa ukubhekelelwa okungcono kanye nokuqashelwa komsebenzi abawenzayo emazingeni ezindawo abahlala kuzona. Lokhu kuzophinde kuqinisekise ukuthi izinhlelo abazenzayo ezibhekene ngqo nezidingo zemiphakathi yabo esikhundleni sokubheka okubekwe ezingeni lesifundazwe. Sifuna nokwenza amavolontiya asebenze nezinhla zemiphakathi zokulwa nobugebengu.

Ukusebenzisana Nezinye Izinhla

Malungu aHloniphekile, impi yokulwa nobugebengu idinga ukubambisana kwezinhla ezahlukene. UmNyango uzohlona bonke okumele babambe iqhaza nokuthi yiliphi lona lelo qhaza ekwakhiweni kombimbi lokulwa nobugebengu, bese usebenza nazo lezi zinhla. Isibonelo nje, njengoba singena sigxila emsebenzini wokwakha kabusha ama-CPF, kumele sicacise iqhaza lalezi zinhla emsebenzini wekomidi ukuze kungabikhona umbango.

Kumele sihlangeane nomNyango wezokuBusa ngokuBambisana nobuHoli beNdabuko ukuze ngokuhlanganyela sicacise iqhaza lama-CPF namakomidi amawadi ekulweni nobugebengu. Ngakolunye uhlangothi futhi umNyango wezokuBusa ngokuBambisana kumele ubheke iqhaza lomasipala ekulweni nobugebengu uqinisekise ukuthi izinhlelo zokunqanda ubugebengu akubi nje





ngezesikhashana, kodwa kuba ngezikhona njalo kuzo zonke izigaba zemiNyango kaHulumeni wethu.

Kumele futhi sibambisane nomNyango wezokuThuthukiswa koMphakathi nabanye ababambe iqhaza ekulweni nokusetshenziswa kwezidakamizwa kuhlenganisa neminye imikhuba engemihle. Njengengxenywe yohlelo lokuqwashisa ngokusetshenziswa kwezidakamizwa, sesike sahlanguana nabadayisi botshwala abasemthethweni. UmNyango uphinde wakha ubambiswano ne-SAPS, umNyango wezokuThutha kanye ne-Liquor Board ngaphansi komNyango wezoMnotho nokuVakasha ukuze senze izithangami ezindaweni ezahlukene ezikhuluma ngokudayiswa nokuphuzwa kotshwala ngendlela enokuzibheka. Lezi zithangami seziqalile e-Dundee naseNquthu.

Kukhona usomqulu ofundisayo owaziwange-‘Making Our School Safe’ oqhubekayo nokulekelela ukusabalalisa ulwazi lwezokuphepha ezikoleni olunikezwa yiwona umNyango ngokubambisana nowezeMfundo. Kulo nyaka sibheke ukuqhubeka nokwakha ubambiswano nomNyango wezemiDlalo nokuNgcebeleka mayelana nohlelo lwezemidlalo oluyingxenywe yokulwa nobugebengu.

I-Justice Crime Prevention And Security Cluster (JCPS)

Malungu aHloniphekile, i-Justice, Crime Prevention and Security Cluster (JCPS), eyakhiwe imiNyango ebhekene nokulwa nobugebengu kanye nebhekene nenhlalakahle, iwuhlelo olusebenza kahle olukwazi ukuletha izidingo ezididiyelwe kubantu bakithi lube futhi luvula inkundla yokuxoxisana nemiNyango emazingeni ahlukene kahulumeni emizamweni yokuvala igebe elikhona ohlelweni lwezobulungiswa nomphakathi. I-JCPS Cluster KwaZulu-Natal isebenza ngokubambisana ngendlela esezingeni eliphezulu futhi engakaze ibonwe. Okunye okuqaphelekayo phakathi kwezinto eziyimpumelelo kulo mkhakha ngokuxazululwa kwezinxushunxushu embonini yamatekisi.

I-JCPS Cluster ibhekene futhi nokulungisa udaba lokwebiwa kwemfuyo olulokhu lusikhathaza njengoHulumeni nabantu abaningi abathintekayo ngalesi simo. Izindawo ezihlonzwe njengezikhungethwe ngukwebiwa kwemfuyo esifundazweni yiseMnambithi, Utrecht, Bulwer, Bergville, Ezakheni, Hlobane, Dannhauser, Amangwe, Paulpietersburg, Vryheid, Ekuvukeni, Estcourt, Nongoma, Elandslaagte, Kwa-Mbonambi, Impendle, Kwa-Msane, Taylor’s Halt, Himeville,



Intsikeni, Maphumulo, Gluckstadt, Besters, Plessisslaer naseDumbe. UmNyango uyazihambela lezi zindawo ukulungisa lesi simo. UmNyango ngokuxhumana nowezoLimo, ezeMvelo nokuThuthukiswa kweziNdawo zasemaKhaya, usingathe uhlelo lokufakwa kophawu emfuyweni esifundazweni sonke. Kunohlelo lokunqanda ukwebiwa kwemfuyo oluhlanganiswe ngokubambisana nemiNyango eyingxenywe ye-JCPS Cluster. Ukunqandwa kwalo mkhuba kuzolekelela kakhulu ukuthuthukisa imiphakathi yakithi esemakhaya.

I-JCPS Cluster izoqhubeka nokubheka izinto ezithinta umthetho. Lokhu kuzohlanganisa ukubheka ukuthi sikhona yini isidingo sokwakha imigomo emisha noma sidinga ukubuyekeza leyo emidala. Okunye futhi ngokubheka ukuthi akuxegi yini ngasohlangothini lokuba kusetshenzwe ngokwale migomo ekhona mhlambe okudinga kulungiswe kona. Kumele ihlele ukungenelela okufanele ngokwenza amakomiti azokwazi ukubhekana ngempumelelo nobugebengu.

Ikomidi elibhekene noshwele kaMongameli liwumqondo we-JCPS Cluster. Kuyimanje leli komidi lenza umsebenzi walo njengoba liyalelwe yi-Cluster. Lesi yisinyathelo esibaluleke kakhulu ekuhlanganisweni komphakathi wakithi. Kodwa kusenomunye umsebenzi odinga ukwenziwa kuleli komidi wokuhlanganisa abebeyiziboshwa nomphakathi wonkana.

Isiphetho

Ucwaningo oluqhubekayo, ukulandelela nokucubungula amasu okulwa nobugebengu yikona okungukhiye wokuphumelela kwezinhlelo zethu zokulwa nobugebengu. Sizowenza lo msebenzi ngokucophelela ukuze sihlale sinamathele ezinhlelweni namasu okulwa nobugebengu.

Njengoba umNyango unesabelo-mali esincane, kusho ukuthi kumele ubheke ukuthi singasikhulisa kanjani ngokuhambisana nezinhlelo zethu, noma ngakolunye uhlangothi sibheke eminye imithombo yezimali zokulekelela imikhankaso yokulwa nobugebengu, ikakhulukazi osomabhizinisi, kodwa hhayi ngokusebenzisa abe-Business Against Crime kuphela.

Sizoqhubeka sisabalalise ulwazi ngamasu nezinhlelo zethu zokulwa nobugebengu ukuze siqinise ukugqugquzelwa kwabantu. Sifuna zonke izifunda, wonke amawadi, yonke imindeneni nawo wonke umuntu ngamunye ukuba azi futhi abambisane nathi ezinhlelweni zethu zokulwa nobugebengu.





Njengamanje sithanda ukudlulisa ukubonga kwethu emaphoyiseni aKwaZulu-Natal ngaphansi kobuholi buka-Lt Gen Ngobeni, ngegalelo abe nalo ekwehleni kobugebengu emikhakheni ethile njengoba kuvelile ezibalweni zobugebengu zakamuva.

Izinga lomsebenzi wabo abawenza ngesikhathi kuqhubeka ukhetho loHulumeni baseKhaya nangemuva kwalo, liyancomeka njengoba bakwazi ukudambisa isimo kwezinye izingxenye zesifundazwe ezazibonakala zingase ziphazamise ukuvota kwabantu ngokukhululeka. Ukubonakala kwamaphoyisa enkanisile kudale impumelelo nangesikhathi sePhasika, esamaholide kaKhisimusi nangesikhathi sengqungquthela yesimo sezulu i-COP 17.

Ngifisa ukubonga kakhulu ikomiti lesikhashana le-CPF eliholwa nguMnuz Sibhaca, izinhloko ezahlukeni zomphakathi ezilwa nobugebengu, ngomsebenzi wabo ekulweni nobugebengu nokuvuma ukusebenzisana nomNyango ngaphansi komthetho nangomoya wokubambisana. Iqhaza lomphakathi njengoba likhonjiswa yizinhloko zokulwa nobugebengu nabo bonke esiyibambe nabo ekwakheni umbimbi lokulwa nobugebengu alidingi ukulokhu ligcizelelwa manje.

Ngifisa futhi ukubonga umNyango wezokuPhepha nokuXhumanisa uMphakathi ngaphansi kobuholi bukaMnuz RV Bhengu ngokungeseka kanye neqhaza labo ekuhambiseni izidingo kubantu. Izinto esikwaze ukuzenza ekulweni nobugebengu zibe yimpumelelo ngenxa yokuzinikela kwenu.

Angeke ngimushiye ngaphandle umama wasekhaya nomndeni wami ngokuhlale bengeseka ngaso sonke isikhathi. KuHulumeni waKwaZulu-Natal, ngaphansi kobuholi bukaNdunankulu sinethulela isigqoko ngegalelo lenu ekwenzeni ngcono izimpilo zabantu bakithi.
