Lesi ngesinye sezizathu ezenza aluleke uhlelo lokucijwa amakhansela kuthi lawo anawo atric acijwe ezikhungweni nifundo ephakene.

UMphthiswa Wezokubusa zokubambisana Nezindaba mdabu uNkk uNomusa uDube Neube wamezela lelo lokuqeqeshwa amakhansela ngesikhathi ula isabelomali. Wathi xenywe yalolu hlelo zoba ukuwacija njengoba iakhanseleni angama-1846, khona angama-234 aqeqeshwe le esikoleni eziningi eliphezulu, gama-322 anomatric kuphela. si ngesinye sezizathu esenza, uth African Local Government sociation (SALGA) Centre Leadership and Governance (LIG), okuyisikhungo cuqeqesha esingaphansi kaSALGA iqale ukusebenzisana maNyvesi ahlukeni okukhona wo neWits ukuze kuqeqeshwe aholi eziningi likaHulumeni asekhaya ezifundweni khethekile.

Lolu budlelwane buqale owezi-2015 ngesikhathi shungo iSCLG sibona jingo sokusebenzisana zinkampani ezizimele nalezo ahulumeni ezinezinhloso faayo nezesikhungo aSALGA. Kuningi ukusizakala abasebenzi bakaHulumeni izingeni aphantsi okusebenzisana neSalga Kwabe sekuphuma isikhangiso cwenza isicelo sokuhlanganisa fundo eziphatelene nobuholi. yuvesi yaseWits yasheshe zemukela inselelo yahlanganisa fundo ezimayelana nobuholi uphathweni komasipala uzibiza ngeLeadership Municipal Governance ogramme.

izifundo ezinesisindo esihloliwe nathi sanikezwa ithuba lokwakha ubudlelwane obuncike kulokho okuvunyelwana ngakho nhlangothi zombili njengokuyizidingo ezimqoka zokwesekela lo mkhakha, kusho imenja eyengamele izifundo uKubeshni Govender-Jones. NgoNdasa walo nyaka kusayindelwe ngokusemthethweni ubudlelwane phakathi kwelizikhungo. Izifundo zokuphatha eziningi lomasipala ezibizwa ngeLeadership in Municipal Governance Programme ziwuhlobo lokuqeqeshwa nokuthuthukiswa okuzazingeni lobuchwepheshe obunqanjwayelelele nobuseqophelweni eliphezulu kwabasezingeni lobuholi bomasipala. Isitifiketi esinikezwa asebebothule izifundo siseqophelweni leNQF Level 7 kanti izinga lokuqeqeshwa liphendula ngqo izidingo zohulumeni bendawo. "Ngexxa yomlando omuhle kwezokuqeqesha nokujula kwezifundo ezinikezwa yisikhungo, iWits School of Governance yakhethwa ngo"elethu" ukuba ngabalingani bethu kulolu hlelo," kuqhuba uGovender-Jones. izinhlelo namafa kamasipala. Okuqeqeshwe wumthamo wezifundo kusezingeni lezifundo ezethulwa yizikhungo zomhlaba ezifana neBhange Lomhlaba nezeNtuthuko laseNingizimu Afrika. Uhlelo alujwayelekile ngoba lubhekele izidingo zalabo abazokuqeqesha nezikamasipala. Inhlosongqangi wukuletha uguquko kwezokuphathwa komasipala ukuze babe yizindawo zokufunda, ukusombululwa kwezinkinga, ukulinga amasu amasha, ukufunda kwabenza kahle nokudluliselwa kolwazi kulabo abaludingayo. UGovender-Jones uthi lolu hlelo luhambisana ncamashi nokwenziwa umhlaba wonke, "ukubalekelana nalokho okujwayelekile okunikezwa yizikole eziqeqesha abamabhizinisi, nokusungula izikhungo ezizezingeni eliphezulu ngaphakathi enhlanganweni leyo ezizokwazi ukuhlanganisa izifundo ezibhekele izidingo zomuntu ngomuntu."
