The Province of KwaZulu-Natal, Department of Transport, invites tenders from Established Contractors, experienced in the construction of roadworks, THE CONSTRUCTION OF A TRIPLE CELLED 1.8M X 1.8M BOX CULVERT AT KM0+124, EARTHWORKS, LAYERWORKS, SURFACING AND ANCILLARY WORKS ON DISTRICT ROAD 1252 (D1252) BETWEEN KM0+000 TO KM3+920 IN THE LADYSMITH REGION. The duration of the project will be **18 months**.

The Established Contractor shall be registered in CIDB contractor grading designation 8CE or higher.

The successful tenderer must subcontract a minimum of 35% of the value of the contract to Targeted Enterprises through Contract Participating Goals (CPG)

Tenderers shall be required to demonstrate that they will have in their employ during the contract period the necessary personnel satisfying the requirements of the Scope of Work for labour-intensive competencies for management and supervisory personnel.

Only tenderers who have access to a suitability qualified and experienced Contract Manager: who will be the single point of accountability and responsibility for the management of the construction works, and who is registered with SACPCMP as PrCM or with ECSA as PrEng/PrTechni are eligible to tender.
