The Province of KwaZulu-Natal, Department of Transport, invites tenders from Established Contractors, experienced in the construction of bridges, for the construction of a Single Celled 1.8m x 1.8m Box Culvert STC4022, Widening of Rapsons Spruit Bridge No. 2772, Single Celled 4.2m x 4.2m Box Culvert STC 2794 and Associated Roadworks on Main Road P187. The duration of the project will be **12 months**.

The Established Contractor shall be registered in CIDB contractor grading designation **8 CE or higher**.

The successful tenderer must subcontract a minimum of 35% of the value of the contract to Targeted Enterprises through Contract Participation Goals (CPG).

Tenderers shall be required to demonstrate that they will have in their employ during the contract period the necessary personnel satisfying the requirements of the Scope of Work for labour-intensive competencies for management and supervisory personnel.
