The Province of KwaZulu-Natal, Department of Transport, invites tenders from Established Contractors, experienced in the construction of roadworks and bridges, THE CONSTRUCTION OF THE UMZIMKHULU (GUMANTANE) RIVER BRIDGE AND ASSOCIATED APPROACHES AND DRAINAGE ON DISTRICT ROAD D919 (KM0+0 TO KM4+0) AND 1121. The duration of the project will be **24 months**.
