It is estimated that interested service providers, for the supply of uniform who satisfy criteria stated in the Tender Data, may submit Tender offers.

Prequalifying Criteria

- The KwaZulu-Natal Department of Transport is applying pre-qualifying criteria for this bid in terms of Regulation 4 of the PPPFA Regulations, 2017. Only tenderers who meet the minimum pre-qualifying criteria will be considered for evaluation and award. The pre-qualifying criteria for this bid are as follows:
- A tenderer who will sub-contract a minimum of 35% of the contract to an EME or QSE which is at least 51% owned by black people that formed a cooperative, youth or women.
- Any tenderer that fails to meet the minimum pre-qualification criteria will be deemed invalid.

This Tender is subject to Local Production and Content Compliance as follow:

- Textile, Clothing, Leather and footwear - 100%.
- Each item must be individually compliant at as evaluation will be at item level.
- Annexure C must be properly completed and returned with the document.
- Annexure D and E must be kept by a service provider for a period of 5 years as proof.
