The Province of KwaZulu-Natal, Department of Transport, invites tenders from Established Contractors experienced in civil engineering, specifically in reinforced concrete bridge works only, for The Construction of the Mhlalane River Pedestrian Bridge No. 3564 in KZ221 Umshwathi Local Municipality. The duration of the project will be 6 months.

The Established Contractor shall be registered in CIDB contractor grading designation 6CE or higher.

Pre-qualification criteria shall apply: Only tenderers with a B-BBEE Status Level of 1 shall be considered.

Any tender that fails meet this minimum pre-qualifying criterion shall be deemed to be Non-Responsive.

The successful tenderer must subcontract a minimum of 6% of the value of the contract to Targeted Enterprises through Contract Participation Goals (CPG).

Tenderers shall be required to demonstrate that they will have in their employ during the contract period the necessary personnel satisfying the requirements of the Scope of Work for labour-intensive competencies for management and supervisory personnel.

Tender documents will be available as from 2 to 13 December 2019 and from 6 to 15 January 2020 during working hours (i.e., 08h00 to 16h00 Monday to Friday).
