The KwaZulu-Natal Department of Transport is applying pre-qualifying criteria for this bid in terms of Regulation 4 of the PPPFA Regulations, 2017. The pre-qualifying criteria for this bid is as follows: A tenderer who will sub-contract a minimum of 35% of the contract to; • an EME or QSE which is at least 51% owned by black people who women; or • an EME or QSE which is at least 51% owned by black people who youth; or • an EME or QSE which is at least 51% owned by black people with disabilities 2. Proof of sub-contracting must be submitted together with the bid. Failure to submit proof of sub-contracting, (e.g. Sub-Contracting Agreement) will invalidate the bid. 3. Subcontractors are not allowed to bid as main contractors. 4.
