1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to all bids:

- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

- a) The value of this bid is estimated to **not exceed** R50 000 000 (all applicable taxes included) and therefore the **80/20** preference point system shall be applicable; or

1.5 Failure on the part of a bidder to submit proof of B-BBEE Status level of contributor together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.

1.6 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

2. DEFINITIONS

- (a) **“B-BBEE”** means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- (b) **“B-BBEE status level of contributor”** means the B-BBEE status of an entity in terms of a code of good practice on black economic empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- (c) **“bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;
- (d) **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (e) **“EME”** means an Exempted Micro Enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;
- (f) **“functionality”** means the ability of a tenderer to provide goods or services in accordance with specifications as set out in the tender documents.
- (g) **“prices”** includes all applicable taxes less all unconditional discounts;

Annual Service and Maintenance – Minor Service

- 1 x Annual service will be carried out in accordance with SANS 1475 on the above fire equipment (1.1 above) by a registered SAQCC technician in our SABS approved workshop.
- Standby loan units will be made available at no additional charge to the client while repairs are carried out. In the event of any loan units being discharged, or be damaged or lost, these loan units will be replaced at our normal rates and charged to the client.

Five yearly hydrostatic test and recharge

- 1 x Five yearly hydrostatic test will be carried out in accordance with SANS 1475 on the above fire equipment (1.1 above) by a registered SAQCC technician in our SANS accredited test station.
- Any costs incurred for hydrostatic testing will be in addition to the standard service fee and charged at our normal rates.

3. VALIDITY / DURATION:

This agreement shall operate with effect from the start of the contract and shall be subject to three calendar months' notice given in writing by either party in the event of termination of the said contract.

4. LIABILITY:

The Contractor shall be liable for any damage of whatever nature, whether consequential, or otherwise, which may be sustained by the owner of the equipment, unless such damage was caused as a result of negligence on the part of FIREQUIP, or its representative.

All workmanship and replacement parts will carry a six month warranty. Any new fire equipment installed by the Contractor will carry a 1 year factory warranty provided it is serviced and maintained by the contractor in accordance with the manufacturer's specification.
