### REQUEST FOR TENDER PROPOSALS FROM ENVIRONMENTAL ASSESSMENT PRACTITIONERS (EAP) OR ENVIRONMENTAL SCIENTISTS FOR STRUCTURES AND ROAD INFRASTRUCTURE PROJECTS FOR A PERIOD OF 3 YEARS.

The Province of KwaZulu-Natal Department of Transport, requests Tender proposals from Environmental Assessment Practitioners (EAP) or Environmental Scientists for Structures and Road Infrastructure projects for a period of 3 Years.

It is envisaged that interested service providers who can provide Environmental Assessment Practitioners or Environmental Scientists who satisfy the criteria stated in the Tender Data, may submit Tender offers.

The Department will be applying pre-qualifying criteria for the appointment of a service provider into the panel in terms of Regulation 4 of the PPPFA Regulations, 2017:

Pre-qualifying criteria for the Environmental Assessment Practitioners (EAP) or Environmental Scientists; Environmental Assessment Practitioners (EAP) or Environmental Scientists for Structures and Road Infrastructure Projects.

- Tenderers must be BBBEE Level 1, 2 or 3 only

All projects in excess of R10 million undertaken through the panel will include a condition requiring the bidder to subcontract a minimum of 35% of the value of the contract to Targeted Enterprises (Exempted Micro Enterprise (EME) or Qualifying Small business Enterprise (QSE) which are at least 51% owned by black people) through Contract Participation Goals (CPG).

Any tenderer that fails to comply with the minimum pre-qualification criteria will be deemed non-responsive and shall not be evaluated further.
