The Province of KwaZulu-Natal, Department of Transport, invites tenders from contractors, experienced in regravelling, for the PROVISION OF ROUTINE AND SAFETY MAINTENANCE ON VARIOUS ROADS WITHIN THE CREIGHTON ZONE - HLANGANANI AREA OFFICE. This project is in the province of KwaZulu-Natal in the district municipality of Nkosazana Dlamini Zuma. The duration of the project is 24 months.

Only tenderers that satisfy the eligibility criteria stipulated in clause C.2.1 of the Tender Data are eligible to have their tenders considered.

It is estimated that tenderers must have a CIDB contractor grading designation 8CE or higher.

Only locally produced or locally manufactured goods with a stipulated minimum threshold for local production and content as stated in the Tender Data will be considered. Failure to meet the minimum threshold for local production and content **will** lead to disqualification.

The successful tenderer will be required to subcontract a minimum of 35.5% of the value of the contract to targeted Enterprises inline with Preferential Procurement Policy Framework Act (PPPFA) Regulations 12 of 2017

Tenderers shall be required to demonstrate that they will have in their employ during the contract period the necessary personnel satisfying the requirements of the Scope of Work for labour-enhanced competencies for management and supervisory personnel.
