CONTRACT NO. ZNB00157/0000/00/HOD/INF/20/T: RESEAL OF PROVINCIAL ROAD P30 (KM 0.000 TO KM 34.300) IN THE LADYSMITH REGION

The Province of KwaZulu-Natal, Department of Transport, invites tenders from contractors, experienced in roadworks, for the Reseal of Provincial Road P30 (Km 0.000 to Km 34.300) in the Ladysmith Region. This project is in the province of KwaZulu-Natal in the district municipality of uThukela and local municipality of Okhahlamba. The duration of the project is 18 months.

Only tenderers that satisfy the eligibility criteria stipulated in clause C.2.1 of the Tender Data are eligible to have their tenders considered.

It is estimated that tenderers must have a CIDB contractor grading designation **8CE or higher**.

Only tenderers who comply with the functionality criteria for experience of key persons, company past performance in similar projects, and proposed approach and methodology, as stated in the Tender Data, are eligible to be considered for further evaluation.

Only locally produced or locally manufactured goods with a stipulated minimum threshold for local production and content as stated in the Tender Data will be considered. Failure to meet the minimum threshold for local production and content **will** lead to disqualification.

The successful tenderer will be required to subcontract a minimum of **35.15%** of the value of the Constructions Works to Targeted Enterprises through Contract Participation Goals (CPG) for the bidder that is BEE Level 1 EME or QSE that is more than 51% owned by black person(s).

Tenderers shall be required to demonstrate that they will have in their employ during the contract period the necessary personnel satisfying the requirements of the Scope of Work for labour-intensive competencies for management and supervisory personnel.

Preferences are offered to tenderers who comply with the requirements stipulated in clause C.3.11.1 of the Tender Data.
