#### 1. BACKGROUND AND PURPOSE

The Department of Transport incorporating the KwaZulu-Natal Department of Transport ("KZNDOT"), is responsible for regulation of Transportation in South Africa, that is, public transport, rail transportation, civil aviation, shipping, freight and motor vehicles. 
Group B – Regular Panels – Please Choose

Contractors are advised to only tender with one company, tendering with more than one company will result to disqualification. This will be verified through CSD with companies registered under director's ID number.

The acknowledgment or non-acknowledgement of this addendum will not lead to any disqualification.

Failure to complete, sign and date this form shall result in the expressions of interest being considered non-responsive in terms of subclause D.2.8 of the Conditions for the calling of Expressions of interest and such an Expressions of interest shall be rejected.

If this footer is displayed and a contractor feels that it is N/A and does not sign the page, the tender will be non-responsive. The content may be marked as N/A if so applicable, but the Bidder must still sign and date the required spaces as instructed. Please note initialling the bottom of the page is not seen as a signature it is simply acknowledging that the bidder has seen the page and is aware of what is in his/her document.
