- 5. There are three (3) stages of Evaluation:
  - a) 1st Administrative Compliance
  - b) 2<sup>nd</sup> Functionality
  - c) 3rd Price
- 6. To be eligible to bid for this Tender you need to be:
  - a) Registered and Active on CSD
  - b) Tax Compliant
  - c) Registered and Active on CIDB
  - d) Be a CIDB grading of 7CE or above
  - e) to comply with the Functionality Criteria
- 7. Only locally produced or locally manufactured goods that meet the stipulated minimum threshold for local production and content will be considered.

- 8. Due to COVID Risks briefings are held virtually, but bidders are encouraged to visit site locality map and coordinates are on page T7
- 9. Tender data will have precedence in the interpretation of any ambiguity or inconsistency between the tender data and the standard conditions of tender.

Bidders must be active on the CSD by the date of closing for this bid and each member of the joint venture has to be registered on the CSD.

Need to be registered and active on CIDB, and need to be of a grading of 7CE or higher.

None of the respondents or its principals may be listed on the register of tender defaulters, and all person listed as prohibited to do business with the state will be eliminated.

The department reserves the right that over and above using any legal remedy, will cancel this Tender..

## Work Scope

### Mr. E King

- THE RESEAL OF ROAD P601-2 FROM KM 29.750 TO KM 39.750 IN THE HARRY GWALA DISTRICT UNDER PIETERMARITZBURG REGION
- The project comprises mainly the surface treatment, using a double seal, 10 millimeters plus 20 millimeters between 29KM to 39 KM's
- Sealing of cracks, minor surface cracks, minor patch work before treatment, small work will be done on concrete drains.
- Curbing and channeling of some guardrails

## Construction Material:

- Commercial materials to be specified, so the contractor will have to identify their own source of material.
- The tender price will include procurement and supply of material to the side.
- There is no stockpiling which is provided in the bill of quantities.

## **Accommodation of Traffic:**

- The contractor will be required to accommodate the traffic in half widths.
- Traffic accommodation is provided for in the Bill of Quantities as well as under Chapter 1.5

## Testing of Materials:

 A prime cost sum has been allocated in Chapter 20 of the BOQ, for any test that would be required by the employer's agent during the implementation of the works.

## Extension of Time for delay due to rain:

- The contract will be using method number 2 of the standard quarter.
- Critical path method with consequential rain delays

# Contract participation goals on the project:

- The tenderer will be expected to subcontract at least 30% of the total value of the works to emerging subcontractors.
- The works of the subcontractors have already been allocated in the document, which will not be priced by the main contractor. A provisional sum has been allocated in the contractors main BOQ for the smaller contractors.
- Expanded public works program, the contactor will be required to implement an EPWP, by using label enhanced technologies to create job opportunities for the local laborer's. The contractor will be expected to spend at least 6% of the total contract value towards the local labor in the area
