The Province of KwaZulu-Natal, Department of Transport, invites tenders from contractors, experienced in roadworks, for The Betterment and Regravelling of Local Road P217 (KM 4+900 TO 7+000) in the Ladysmith Region. This project is in the province of KwaZulu-Natal in the Amajuba District Municipality and Emadlangeni Local Municipality. The duration of the project is 4 months.

Only tenderers that satisfy the eligibility criteria stipulated in clause C.2.1 of the Tender Data are eligible to have their tenders considered.

Tenders must have a minimum CIDB contractor grading designation of 5CE or higher.
