

TENDER NOTICE

ZNB01897/00000/00/DUN/INF/23/T: THE REGRAVELLING OF ROAD P372(KM 0 TO KM4.1) IN THE NQUTHU AREA

The Province of KwaZulu-Natal, Department of Transport, invites tenders from contractors, experienced in roadworks, for the Regravelling of Road P372 in Nquthu Area. This project is in the province of KwaZulu Natal in the district municipality of UMzinyathi and local municipality of Nquthu. The duration of the project is 3 months.

Only tenderers that satisfy the eligibility criteria stipulated in clause C.2.1 of the Tender Data are eligible to have their tenders considered.

Tenders must have a minimum CIDB contractor grading designation of 4CE or higher.

Only locally produced or locally manufactured goods with a stipulated minimum threshold for local production and content as stated in the Tender Data will be considered. Failure to meet the minimum threshold for local production and content will lead to disqualification.

Tenderers shall be required to demonstrate that they will have in their employ during the contract period the necessary personnel satisfying the requirements of the Scope of Work for labor-enhanced competencies for management and supervisory personnel. (if applicable)

Preference points are offered to tenderers who comply with the requirements of PPPFA Regulations, 2022 as stipulated in clause C.3.11.1 of the Tender Data.

Department of Transport reserves a right not to award more than one contracts per service provider within the region.

Shortlisted bidders might undergo risk assessment where necessary.
