The Province of KwaZulu-Natal, Department of Transport, invites tenders from contractors, experienced in roadworks, for The Betterment and Regravelling of District Road D327 (KM 0+000 TO KM 5+000) in the Ladysmith Region. This project is in the province of KwaZulu-Natal in the Amajuba District Municipality and Newcastle Local Municipality. The duration of the project is 4 months.
