The Province of KwaZulu-Natal, Department of Transport, invites tenders from contractors, experienced in roadworks, for The Blacktop Patching on Provincial Road P37 (KM 0+000 TO KM 35+400) in the Ladysmith Region. This project is in the province of KwaZulu-Natal in the Amajuba District Municipality and Emadlangeni Local Municipality. The duration of the project is 4 months
