The Province of KwaZulu-Natal, Department of Transport, invites tenders from contractors, experienced in routine road maintenance for the **PROVISION OF ROUTINE AND SAFETY MAINTENANCE ON VARIOUS ROADS WITHIN ZONE 5 - UMZIMKHULU AREA OFFICE**. This project is in the province of KwaZulu-Natal in the District Municipality of Harry Gwala and Local Municipality of Umzimkhulu. The duration of the project is 24 months.

Only tenderers that satisfy the eligibility criteria stipulated in clause C.2.1 of the Tender Data are eligible to have their tenders considered.

Tenders must have a minimum CIDB contractor grading designation of 8CE or higher.

Any tenderer that fails to meet the Prequalifying Criteria/ Local Production and Content/ Subcontracting as condition of tender requirements will be deemed invalid.

Preference points are offered to tenderers who comply with the requirements of PPPFA stipulated in clause C.3.11.1 of the Tender Data.


