The Amendments to be made to this document are as follows:

1. Please refer to page 1 - Mandatory requirements

Remove:

- 1.1 The bidder must provide a bank guarantee letter with a minimum of R300 000 at the time of closing. The bank guarantee must be valid on award of allocation.

This Mandatory requirement is replaced and reads as follows:

- 1.1 The bidder must provide a bank guarantee letter or a bank statement not older than seven (7) days with a minimum of R300 000.00 as proof of availability funds at the time of closing of the bid.
- 1.2 Either the bank guarantee letter must be valid prior to allocation or bank statement not older than seven (7) days with the minimum R300 000.00 balance must be available prior to allocation. Proof of this will be required prior to allocation and failure to submit the department therefore reserves the right not to allocate.
- 1.3 The bank guarantee letter or bank statement must be in the name of the registered legal entity submitting the bid (as per CSD) not an individual. These documents **MUST** be original documents that are bank certified (stamped) and signed. **Copies will not be accepted.**




