1st Stage: Administrative Compliance:

- (a) Bidders must be registered and Active on CSD
- (b) None of the respondents or its principals may be listed on the register of tender defaulters, and all person listed as prohibited to do business with the state will be eliminated.
- (c) Tender Closes on the 08th July 2024 at 11:00, no late entries will be considered.
- (d) Validity period is 12 weeks from date of closing of this tender.
- (e) Bidders are advised to obtain their own copies of the relevant acts, regulations and standards referred to in this document.
- (f) Tender data will have precedence in the interpretation of any ambiguity or inconsistency between the tender data and the standard conditions of tender.
- (g) Only Original documents filled in ink deposited in the Tender Box will be accepted.

- Q1- T49, Key Personnel. Can we submit the same Employer's Agents name on each schedule?
- A1- The answer is no. On T49, 1 Personnel to be assigned on each Key Personnel.
- Q2- Can the above be reviewed?
- A2- The request is noted but the requirements are stipulated on the document
- Q3- T24 Addendum, how can we respond and get the addendum?
- A3- The addendum will be posted on the Departmental website
- Q4- The ranking of the panels on page T13. Please clarify if we mark it with an X per order of preference? On Returnable R, it does not state ranking
- A4- Please indicate a priority. An addendum will be issued
- Q5- Reference letters of clients. Do we submit 5 copies of references, one copy for each project?
- A5- Attach one letter per project
- Q6- On Section O, do we attach all CVS and academic records? Do we attach on Section H or O?
- A6- Page T57, is a guide to assist with Key Personnel. Attach CV's and qualification. Section H is for attachments. Section O is a technical proposal, which is a guideline to structure Section H

- Q7- On T48, are we still allowed to attach projects that are still on going in terms of dates?
- A7- Only work that has been completed will be looked at. Work that has not been completed will not receive any points
- Q8- The Key Personnel of 6 years' experience in Road Upgrades post qualification in Geometric and Pavement Design. Please clarify if the Lead Design Engineer is required to have both experiences or one will suffice?
- A8- Page T14, the Lead Design must be registered with ECSA as a PrEng or Pr Tech Eng minum 6 years' experience in design and construction of Road Upgrade post qualification. The Lead Design Engineer shall be a Category C personnel
- Q9- Page T49, can we reduce requirements to cater for emerging consultants?
- A9- The request is noted and will be escalated to the Department of Transport seniors
- Q10- Will targeted enterprises be required at the RFQ stage?
- A10- Not applicable at this stage. They will be required during quotation stage
- Q11- T40, do we not sign the Declaration?
- A11- Not applicable at this stage
- Q12- Page C 3.1.1, CIDB Build Programme. How do we apply it?
- A12- C22, Paragraph 5. Provide 150 hours of training on a project by project basis. C66, the CSDG, to provide certification for that
- Q13- The 2022 panel that was advertised, what happened to it?
- A13- Information will be provided to the public by DOT
- Q14- Is this panel IDT?
- A14- The panel is not IDT
