The Province of KwaZulu-Natal, Department of Transport, invites tenders from contractors, experienced in roadworks, for betterment of steep gravel section to concrete pavement on district road D944, between km 0.00 to km 2.86 in Ray Nkonyeni local municipality within the Durban region for grade 3CE or higher. The duration of the project is 3 months.

### THE NATIONAL INDUSTRIAL PARTICIPATION PROGRAMME

### INTRODUCTION

The National Industrial Participation (NIP) Programme, which is applicable to all government procurement contracts that have an imported content, became effective on the 1 September 1996. The NIP policy and guidelines were fully endorsed by Cabinet on 30 April 1997. In terms of the Cabinet decision, all state and parastatal purchases / lease contracts (for goods, works and services) entered into after this date, are subject to the NIP requirements. NIP is obligatory and therefore must be complied with. The Industrial Participation Secretariat (IPS) of the Department of Trade and Industry (DTI) is charged with the responsibility of administering the programme.

### 1 PILLARS OF THE PROGRAMME
