MINUTES OF SITE MEETING HELD AT CC METRO BOARDROOM ON 19 AUGUST 2024 AT 10H00

1. ATTENDANCE REGISTER

Attendance registers were circulated amongst all contractors who were present by SCM staff from Cost Centre Metro and Regional Office at 08:30, under the restriction rule that only one representative for each company is allowed to sign attendance register. Two hundred and eighty four company representatives attended site meeting.

2. OPENING & WELCOME

The meeting was officially opened at 10H00 by Ms Makhosane Cele. She introduced herself, SCM staff and Technical staff and welcomed everyone present.

3. DISCUSSION POINTS

The following bid was advertised under Cost Centre eThekweni Metro within the Durban Region:
CONTRACT NO. ZNB02409/00000/00/MET/NF/24/T: BETTERMENT & REGRAVELLING ON
DISTRICT ROAD D12 FROM 0.00 TO KM 2.23 ETHEKWINI METRO.

Ms Sindiile Zibane informed contractors that closing date for the bid is 08 August 2024 at no.4 Aubrey Road, West Mead. She touched on terms and conditions of the document such as the permitted colour of ink to be used which is eligible black ink, no tippex. She then went through the bid document in respect of SCM and advised contractors to read through.

- T18 – Standard Bidding Document – SBD 1 – Part A and T20, Part B – Terms and Conditions
- T21 – SBD 4 – Bidder's Disclosure – tenders to declare conflict of interests
- T26 – SBD 6.1 – Preference Points
- T27 – Specific Goals page must be read in conjunction with T47
- T30 – B-BBEE EXEMPTED AFFIDAVIT FOR EXEMPTED MICRO ENTERPRISES –
- CIDB Document for Construction – tenderers were advised to fill and return this form with Commissioner of Oath's signature
- T42 to T43 – BIDDERS HEALTH AND SAFETY DECLARATION – tenders were advised

to read instruction carefully while filling this part of the document.

After finishing her part, Sindile Zibane handed over the meeting to Mr Clive Naidoo to discuss the give contractors clarity on T41 – TENDERER'S DECLARATION WITH RESPECT TO PARTICIPATION IN JOB CREATION USING LOCAL LABOUR.

Clive thoroughly explained this part, he asked them to pay attention on the local labour percentage that it must not be lower than the Departmental and that the duration is three months which is 66 days and also advised them of the current labour rate which is R47.89.

4. ADDENDUM

Mr Sifundo Shangase informed contractors that addendum regarding correction of an error occurred on page T25 – GENERAL CONDITIONS – 90/10 instead of 80/20, will be published on website (where tender was advertised) and he advised them to print and attach it on the document.

No questions were asked. The meeting was adjourned at 10:25 am

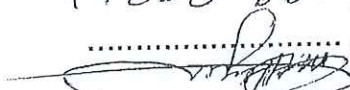
