Upon completion of his presentation, the floor was given an opportunity to raise or seek clarity on any areas of concerns. Seeing that there were not matters of importance raised, Mr Govender then handed over the meeting to his colleague Mr M Sikhakhane.

TECHNICAL

Mr M. Sikhakhane discussed the 4 contracts, scope of work, BOQ, Project specification, Amendment. Each contract differs, maintenance for a period of 3 years, grass cutting, guardrail, blading , etc.

All four documents has CPG - 30%. In terms of working of the contract for each year. Set amount of work and budget for the 1st year, system in place how work will be split for 3 years. CPG is clear line out but this document is different. Each item will be priced. When the supplier is awarded then the CPG will be discussed as it is a maintenance contract. One representative per set of tenders. In terms of the drawings a “state that the drawing will be given to the contractor’s”- NO as it is maintenance contracts.




