The Province of KwaZulu-Natal, Department of Transport, invites tenders from contractors, experienced in roadworks, for The Betterment and Regravelling of Local Road L1156 (KM 1+000 TO 1+500) in the Ladysmith Region. This project is in the province of KwaZulu-Natal in the UThukela District Municipality and Inkosilanga libalele Local Municipality. The duration of the project is 2 months.

Only tenderers that satisfy the eligibility criteria stipulated in clause C.2.1 of the Tender Data are eligible to have their tenders considered.
