The Province of KwaZulu-Natal, Department of Transport, invites tenders from contractors, experienced in roadworks, for the BETTERMENT AND REGRAVELLING OF 2,8 KM ON ROAD P365 FROM 12+700 TO 15+500 IN MSINGA AREA. This project is in the province of KwaZulu-Natal in the district municipality of UMzinyathi and local municipality of Msinga. The duration of the project is 3 months.

Only tenderers that satisfy the eligibility criteria stipulated in clause C.2.1 of the Tender Data are eligible to have their tenders considered.

Tenders must have a minimum CIDB contractor grading designation of 4CE or higher.
