ZNB02325/00000/00/LAD/INF/24/T: THE REHABILITATION AND SLIP FAILURE REPAIRS AT MAIN ROAD P340 KM 36.00 IN THE UTHUKELA DISTRICT UNDER LADYSMITH REGION

The Province of KwaZulu-Natal, Department of Transport, invites tenders from contractors, experienced in roadworks, for the slip failure repair and reconstruction of Main Road 340 (P340) at km 36.00, in the Ladysmith Region. This project is located in the Okhahlamba Local Municipality under the uThukela District Municipality. The duration of the project is 6 months.

Only tenderers that satisfy the eligibility criteria stipulated in clause C.2.1 of the Tender Data are eligible to have their tenders considered.

Tenders must have a minimum CIDB contractor grading designation of 6CE or higher.

Only tenderers who comply with the functionality criteria for experience of key persons, company past performance in Specialised Road projects, i.e. Road Upgrade as stated in the Tender Data, are eligible to be considered for further evaluation.

Tenderers shall be required to demonstrate that they will have in their employ during the contract period the necessary personnel satisfying the requirements of the Scope of Work for labour-enhanced competencies for management and supervisory personnel. (if applicable)

Preference points are offered to tenderers who comply with the requirements of PPPFA Regulations, 2022 as stipulated in clause C.3.11.1 of the Tender Data.

Shortlisted bidders might undergo risk assessment where necessary.
