#### 2. OPENING & WELCOME

The meeting was officially opened at 10H00 by Ms Slindile Zibane. She introduced herself, SCM staff and Technical staff and welcomed everyone present. Ms Zibane extended her appologies for the inconveniences caused regarding the date of the clarification site meeting being Monday 09 Sepetember 2024 and not Tuesday 09 Sepetember 2024.

## 3. **DISCUSSION POINTS**
