The Province of KwaZulu-Natal, Department of Transport, invites tenders from contractors, experienced in roadworks, for Blacktop patching of Main Road P34-1 (km 0+000 TO km 25+500) in the Ladysmith Region. This project is in the province of KwaZulu-Natal in the Amajuba LOCAL Municipality and Dannhuaser Local Municipality. The duration of the project is 3 months.

Only tenderers that satisfy the eligibility criteria stipulated in clause C.2.1 of the Tender Data are eligible to have their tenders considered.

Tenders must have a minimum CIDB contractor grading designation of **4CE or higher**.
