The Province of KwaZulu-Natal, Department of Transport, invites tenders from contractors, experienced in roadworks, for Blacktop Patching of Provincial Road P211 (Km 0+00 TO Km 30+389) in the Ladysmith Region. This project is in the province of KwaZulu-Natal in the Amajuba District and Newcastle Local Municipality. The duration of the project is **4 months**.

Only tenderers that satisfy the eligibility criteria stipulated in clause C.2.1 of the Tender Data are eligible to have their tenders considered.

Tenders must have a minimum CIDB contractor grading designation of **4CE or higher**.

Preference points are offered to tenderers who comply with the requirements of PPPFA Regulations, 2022 as stipulated in clause C.3.11.1 of the Tender Data.
