This project is in the province of KwaZulu-Natal in the district municipality of Mzinyathi. The duration of the project is 3 months

Tenders must have a minimum CIDB contractor grading designation of 3CE or higher.

Tenderers shall be required to demonstrate that they will have in their employ during the contract period the necessary personnel satisfying the requirements of the Scope of Work for labour-enhanced competencies for management and supervisory personnel.

Preference points are offered to tenderers who comply with the requirements of PPPFA Regulations, 2022 as stipulated in clause C.3.11.1 of the Tender Data.
