ZNB02833/00000/00/EST/INF/25/T: REHABILITATION AND SLIP FAILURE REPAIRS AT MAIN ROAD P281 IN THE ALFRED DUMA LOCAL MUNICIPALITY UNDER THE LADYSMITH REGION

The Province of KwaZulu-Natal, Department of Transport, invites tenders from contractors, experienced in roadworks, for rehabilitation and slip failure repairs at main road P281 in the Alfred Duma local municipality under the Ladysmith region. This project is in the province of KwaZulu-Natal in the uThukela District and Alfred Duma Local Municipality. The duration of the project is 6 months.

Only tenderers that satisfy the eligibility criteria stipulated in clause C.2.1 of the Tender Data are eligible to have their tenders considered.

Tenders must have a minimum CIDB contractor grading designation of **6CE or higher**.

Tenderers shall be required to demonstrate that they will have in their employ during the contract period the necessary personnel satisfying the requirements of the Scope of Work for labour-enhanced competencies for management and supervisory personnel.

Preference points are offered to tenderers who comply with the requirements of PPPFA Regulations, 2022 as stipulated in clause C.3.11.1 of the Tender Data.

Shortlisted bidders might undergo risk assessment where necessary.

The tender offer validity period is twenty-four (24) weeks, calculated from the date of bid closure.
