The Province of KwaZulu-Natal, Department of Transport, invites tenders from Engineering Consultants, experienced in Structures and Upgrades, to provide professional services for the construction of Sundays River Pedestrian Bridge (KwaNogejane) and its approaches. This project is located in the Alfred Duma Local Municipality under the uThukela District Municipality in the Ladysmith Region. The total duration of the project is 20 months. The duration allowed for is to achieve all 6 Engineering Council of South Africa (ECSA) Normal Fee Services stages.

Only bidders that satisfy the eligibility criteria stipulated in the Tender Data and who comply with the functionality criteria for experience of key persons, company experience in Specialised/Complex projects, as stated in the Tender Data, are eligible to be considered for further evaluation.

Bidders shall be required to demonstrate that they will have in their employ during the contract period the necessary personnel satisfying the requirements of the Scope of Work.

The requirements of the CIDB B.U.I.L.D. Programme with respect to the Standard for Skills Development is set at 150 hours per R 1 000 000 tendered. (As per CIDB B.U.I.L.D Programme - only applicable to professional services that are R5 million and above and minimum duration of 12 months)..

Preference points awarded for Specific Goals are offered to tenderers who comply with the requirements as stipulated in clause C.3.11.1 of the Tender Data.

Shortlisted bidders might undergo risk assessment where necessary.
