# REQUEST FOR PROPOSALS

## INVITATION OF PROPOSALS FROM SUITABLY QUALIFIED CONSULTANTS TO ESTABLISH ROAD TRAFFIC INSPECTORATE COMMAND CENTRE

### 1. BACKGROUND

The Department is currently running a number of decentralized systems such as Road Safety Mpimpa Call Centre, Road Traffic Communications SMS System, Number plate Recognition System, Average Speed, e-Natis, Trafman.

The Master System Plan that was developed envisages a consolidated command centre with the following high level functionality as the requirement:

- Road Traffic Inspectorate response centre;
- Critical incident management( including web based electronic occurrence book);
- Implementation of Fleet Management /Vehicle tracking system which the Inspectorate does not currently have;
- 24 hour operations;
- Appropriate and effective radio communication network;
- Centralised register and Control Room;
- Monitoring and follow up of investigations;

The master systems plan also lists the following initiatives:

- Links from external service providers that monitor traffic on provincial roads.

### 2. OBJECTIVE

The Department would like to have a command/response centre to facilitate the efficient and effective management of traffic related incidents and information within the province. Therefore the services of an Analyst are required in respect of obtaining the requirements for tender for such a venture. The intention of the Department is to establish the command centre in line with national and international standards. The following directorates are the main stakeholders of this project:

- a) Road Traffic Inspectorate;
- b) Public Transport Enforcement Unit;
- c) Road Safety;
- d) Motor Transport Services;

- e) Public Transport.

### 3. SCOPE OF WORK

#### **An Analyst is to be appointed to:**

- a) Provide expert knowledge and advice to the Department in respect of command centre and response centres.
- b) Interview all the stakeholders in order to obtain the overall business requirements that will inform the Department as to what business issues the Command/Response Centre is to address.
- c) Prioritise these requirements within the different business units into a scale of critical, essential, important, and nice to have.
- d) Consult with industry as to possible solutions in respect of the business requirements and obtain budgetary costs for such solutions.
- e) Consultation with the Project Manager in respect of available finances and Departmental priorities.
- f) Determine a project phasing and User Requirements Document.
- g) Provide a document for tender for phase 1 which address the following:

#### LOCATION

A comprehensive survey must be conducted relating to the current building within the Department that can house the command centre. Should there be inadequate spacing available, alternative measures must be recommended. Consideration must be given to size, layout, communication requirements, IT requirements, offices, boardroom, resting area, and office furniture and abolition facilities. A detailed floor plan must be developed pertaining to the layout. The command centre will be located in Pietermaritzburg under the control of the KZN Department of Transport. Other emergency services like SAPS, EMRS, Municipal Traffic, and Fire Department will be invited to form part of the command centre, therefore, there must be adequate spacing to accommodate these services. The command centre must be user friendly for persons with disabilities i.e. (wheel chair). All IT and furniture requirements must be clearly specified.

#### PERSONNEL

An in depth analysis must be conducted to determine the staffing requirements to operate the command centre on a 24 hour / 365 days basis. The analysis must be broken up as follows:

- Number of operators per shift including detailing their roles and responsibilities;

- Number of supervisors per shift including detailing their roles and responsibilities;
- Person overall in charge including their roles and responsibilities.

Language preferences must be stipulated. Persons with disabilities must be catered for.

### COMMAND CENTRE SOFTWARE

These are the fundamental software requirements forming part of incident management; however additional software can be included:

- Web based call taking, despatch and Resource Management Software
- CTI integration with existing telephone system
- SMS Message Software Module and Bulk SMS subscription
- Voice Recording System
- Fleet Management and vehicle tracking
- One electronic occurrence book for all stations within the province defined user parameters
- Video walls that enable information to be displayed

### RADIO NETWORK

A detailed analysis of the current radio network used by the Road Traffic Inspectorate and Special Operations must be conducted with the aim of having one radio communication network within the province. The communication range must be of such nature that the command centre will be able to communicate with stations and vehicles throughout the province from Pietermaritzburg. Currently the Inspectorate utilising the midband and trunking radio networks within the province. The radio network should be able to integrate with telephone system.

### INTERGRATION OF EXISTING SOFTWARE INTO THE COMMAND CENTRE

All applicable software programmes that are currently being used in the various fields of law enforcement will need to be integrated into the command centre. The following is a list of current software which is not exhaustive:

- SMS;
- Radio Network.

Subsequent phases must consider the integration of the following software:

- Average Speed;
- ANPR (Number plate recognition system);
- Weighing modules;
- Trafman (camera prosecutions, weighing and capturing of prosecutions);
- Alcohol testing.

## LINKS FROM EXTERNAL SERVICE PROVIDERS

e-Natis – National Traffic Information System. This link must be implemented during the initial phase as it will form an integral part of the operations of the command centre.

Camera links that are currently being utilised by external service providers like Sanral, Durban Metro and South African Police Services to monitor major routes in the province needs to be investigated with the intention of being incorporated into the command centre.

## COSTING

The service provider must base their costs on:

- Costing to set up must be broken down in line with the project scope.
- The cost must include disbursement and VAT.

Department is expecting the analyst to advise the Department on a way forward. It must be noted that the service provider appointed in terms of this RFP, will be required to develop tender specifications, and thus will not be permitted to tender for such services.

## **4. DATA SOURCE**

The following data can be made available to the successful consultant:

- Road Traffic Inspectorate – Vehicle tracking;
- 2010 joint operations centre requirements;
- Traffic Management centre (City of Cape Town);
- Information Technology Master Systems Plan;
- Various articles on different commercial response centres;
- Current Mpimpa Call Centre Operation and System;
- Various notes taken during meetings;
- Type of calls;
- Accident Recording Form;
- Communication Manual;
- Specifications on trunking network;
- Specifications on maintenance of midband radios;
- Information on average speed;
- Incident Management Protocols.

## 5. DURATION OF ENGAGEMENT

The duration of this engagement will be for a period of six (6) months.

## 6. COMMUNICATION

The Department will establish the communication procedures and processes for all consultation. The Analyst will be required to ensure that the Department is regularly informed of project progress. The channel of communication will be strictly through the Office of General Manager or his delegate.

## 7. CONDITION OF THE CONTRACT

- The service provider appointed in terms of this RFP, will be required to develop tender specifications, and thus will not be permitted to tender for such services.
- The successful service provider will be required to sign a formal contractual agreement with the Department and will be bound by the terms and conditions contained therein. No appointment will be deemed to be finalized without the agreement being signed by the contracting parties.
- It is expected that a schedule of deliverables including a structured breakdown of work (containing a list of tasks), and proposed meetings dates be included in the proposal,
- A proposal should include costs and time schedule of deliverables, estimate of hours for each member of the team/consortium in their specific areas of expertise.
- The successful service provider is expected not to discuss or make any information available to any member of the public, press, other bidder or any other unauthorized person (s) except as authorized by the General Manager: Advocate Chamane or his delegate.

## 8. EVALUATION CRITERIA

The proposals that are received from Consultants for this project will be evaluated in terms of Supply Chain Management (SCM) Provincial Policy Framework.

The evaluation criteria for functionality will be weighted and considered in the selection process as follows:

Minimum qualification score for functionality will be 50. Bidders scoring less than 50 functionality points will be disqualified.

Points will be awarded as follows:

- Price (90)
- Preference Points (10)

The Department reserves the right to invite Service Provider/s for interviews, should there be a need. The Department further reserves the right to utilize information received in the interviews process for evaluation purposes.

- 2.3 **“B-BBEE status level of contributor”** means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- 2.4 **“bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of services, works or goods, through price quotations, advertised competitive bidding processes or proposals;
- 2.5 **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- 2.6 **“comparative price”** means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration;
- 2.7 **“consortium or joint venture”** means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;
- 2.8 **“contract”** means the agreement that results from the acceptance of a bid by an organ of state;
- 2.9 **“EME”** means any enterprise with an annual total revenue of R5 million or less.
- 2.10 **“Firm price”** means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- 2.11 **“functionality”** means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- 2.12 **“non-firm prices”** means all prices other than “firm” prices;
- 2.13 **“person”** includes a juristic person;
- 2.14 **“rand value”** means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- 2.15 **“sub-contract”** means the primary contractor’s assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;
- 2.16 **“total revenue”** bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;

- 5.2 Bidders who qualify as EMEs in terms of the B-BBEE Act must submit a certificate issued by an Accounting Officer as contemplated in the CCA or a Verification Agency accredited by SANAS or a Registered Auditor. Registered auditors do not need to meet the prerequisite for IRBA's approval for the purpose of conducting verification and issuing EMEs with B-BBEE Status Level Certificates.
- 5.3 Bidders other than EMEs must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a Registered Auditor approved by IRBA or a Verification Agency accredited by SANAS.
- 5.4 A trust, consortium or joint venture, will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 5.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- 5.6 Tertiary institutions and public entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.

- 5.8 A person awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capability and ability to execute the sub-contract.
